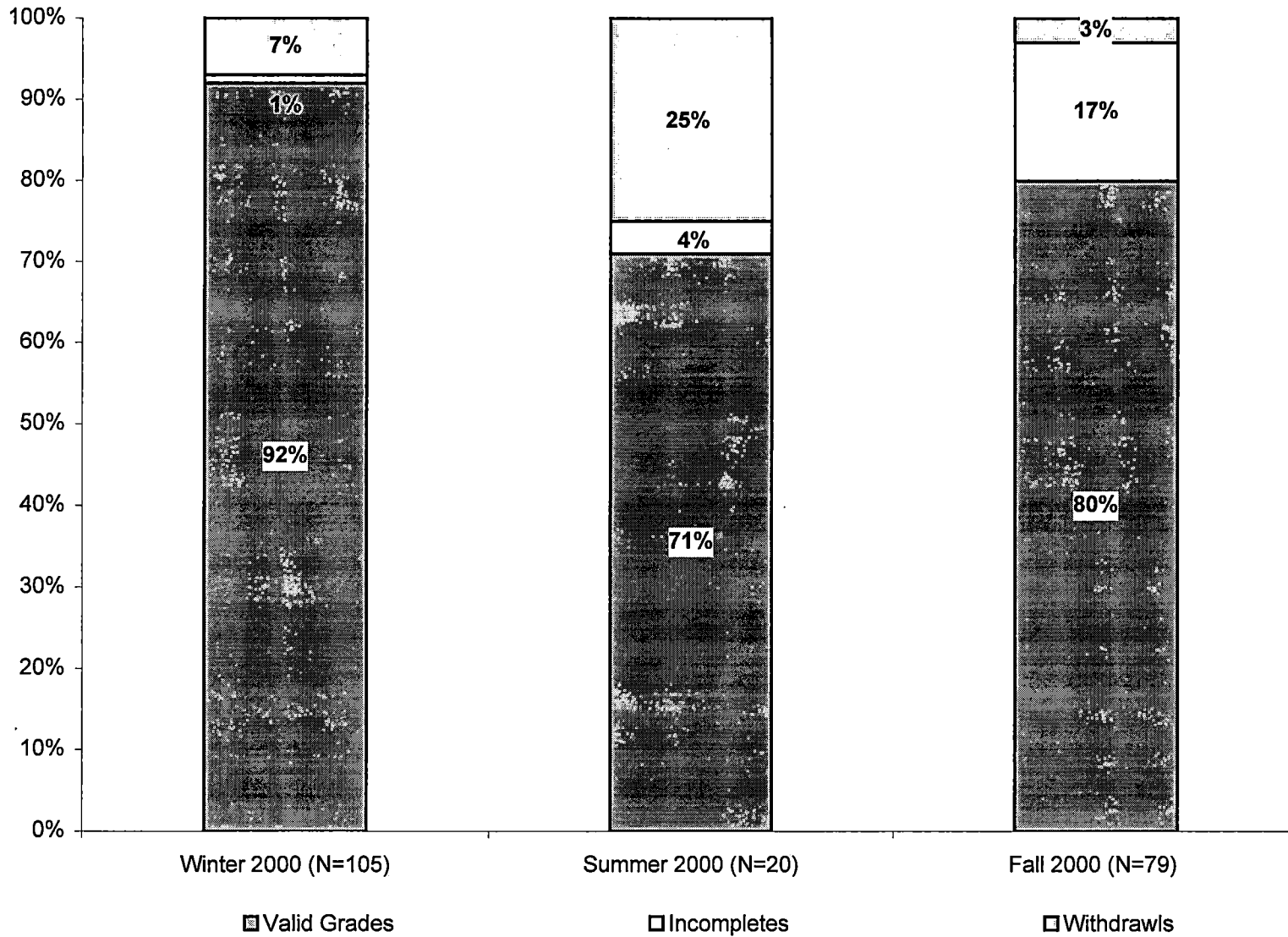

Figure 1.2 LGL 210 (Legal Research 1)

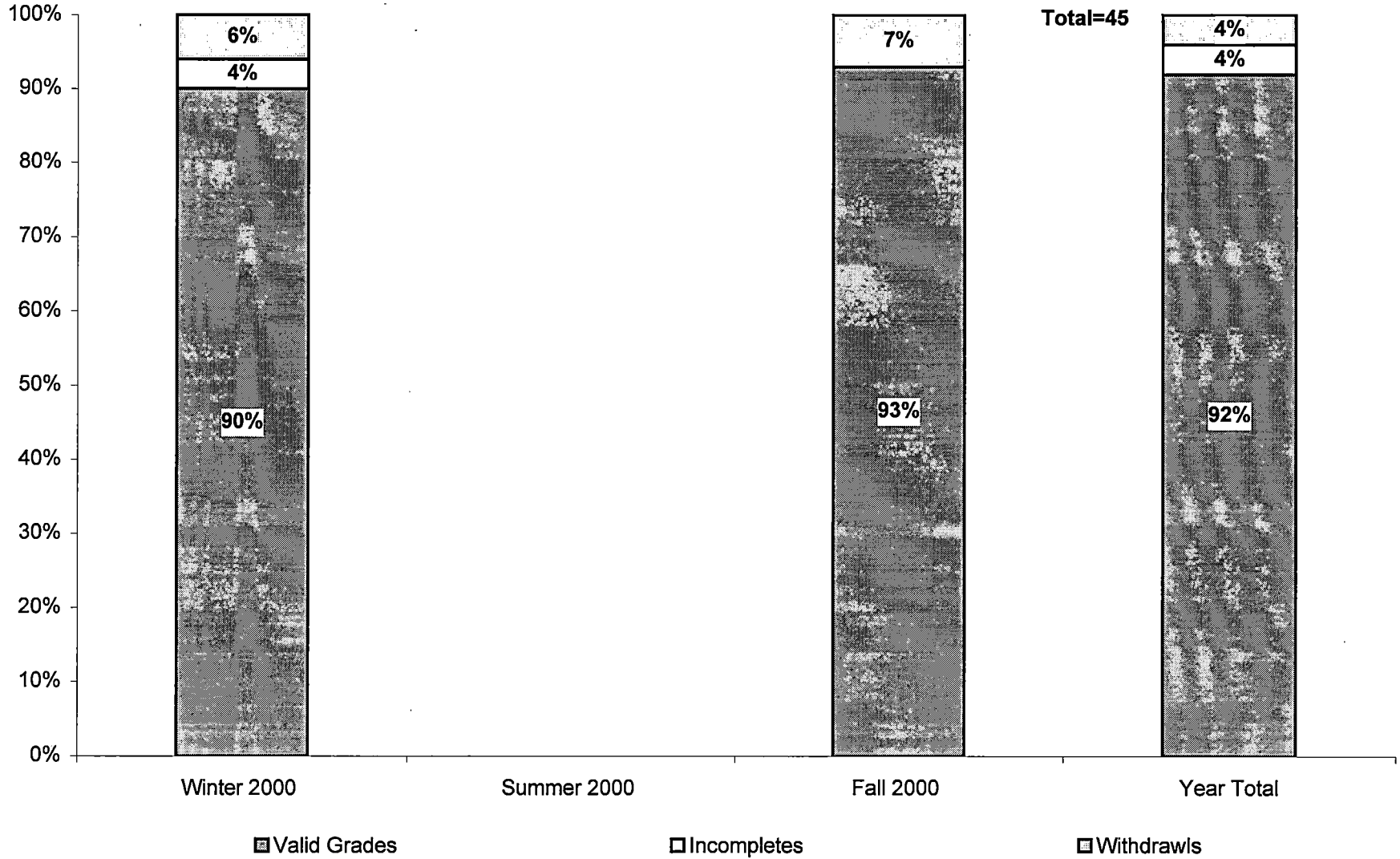

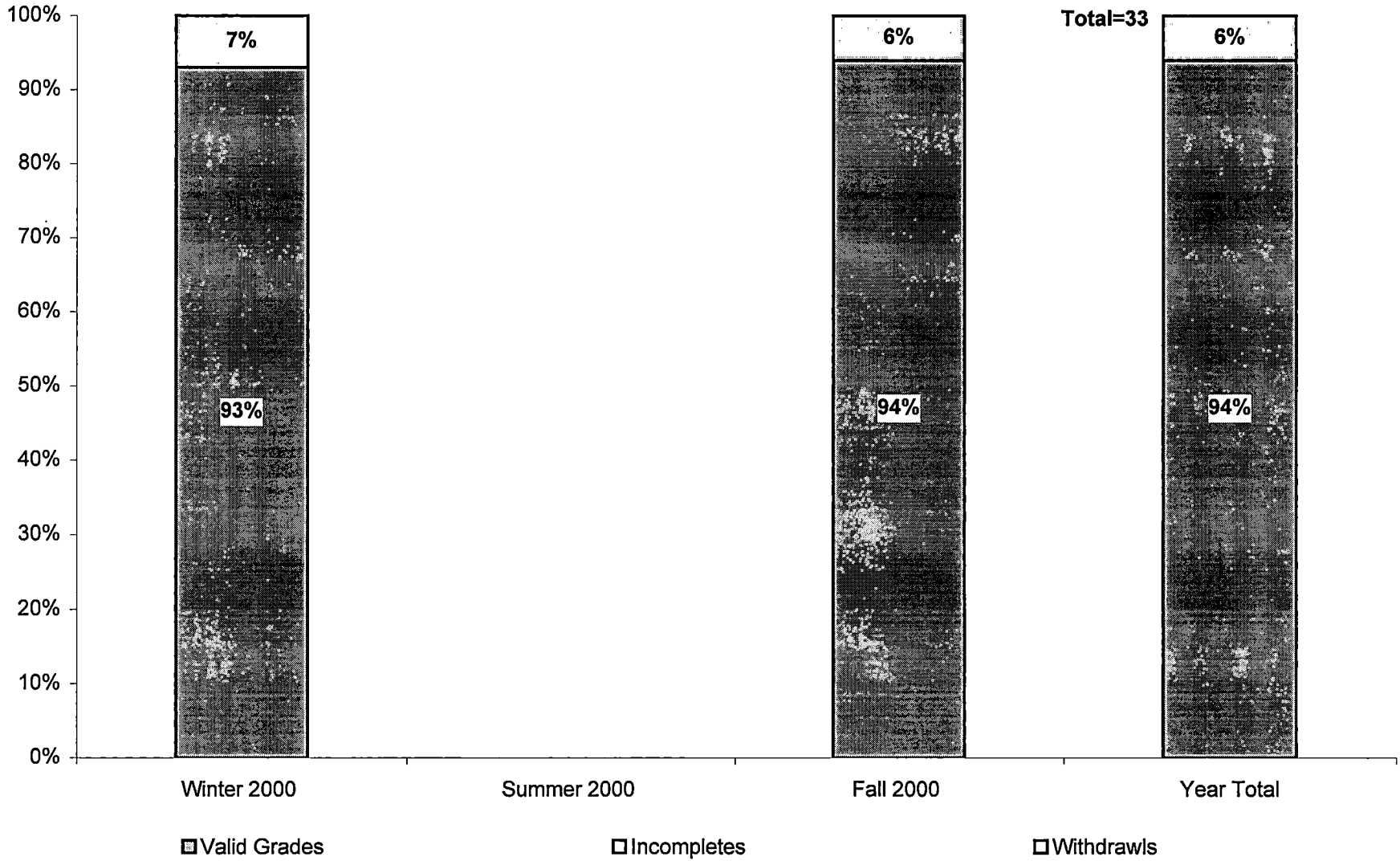

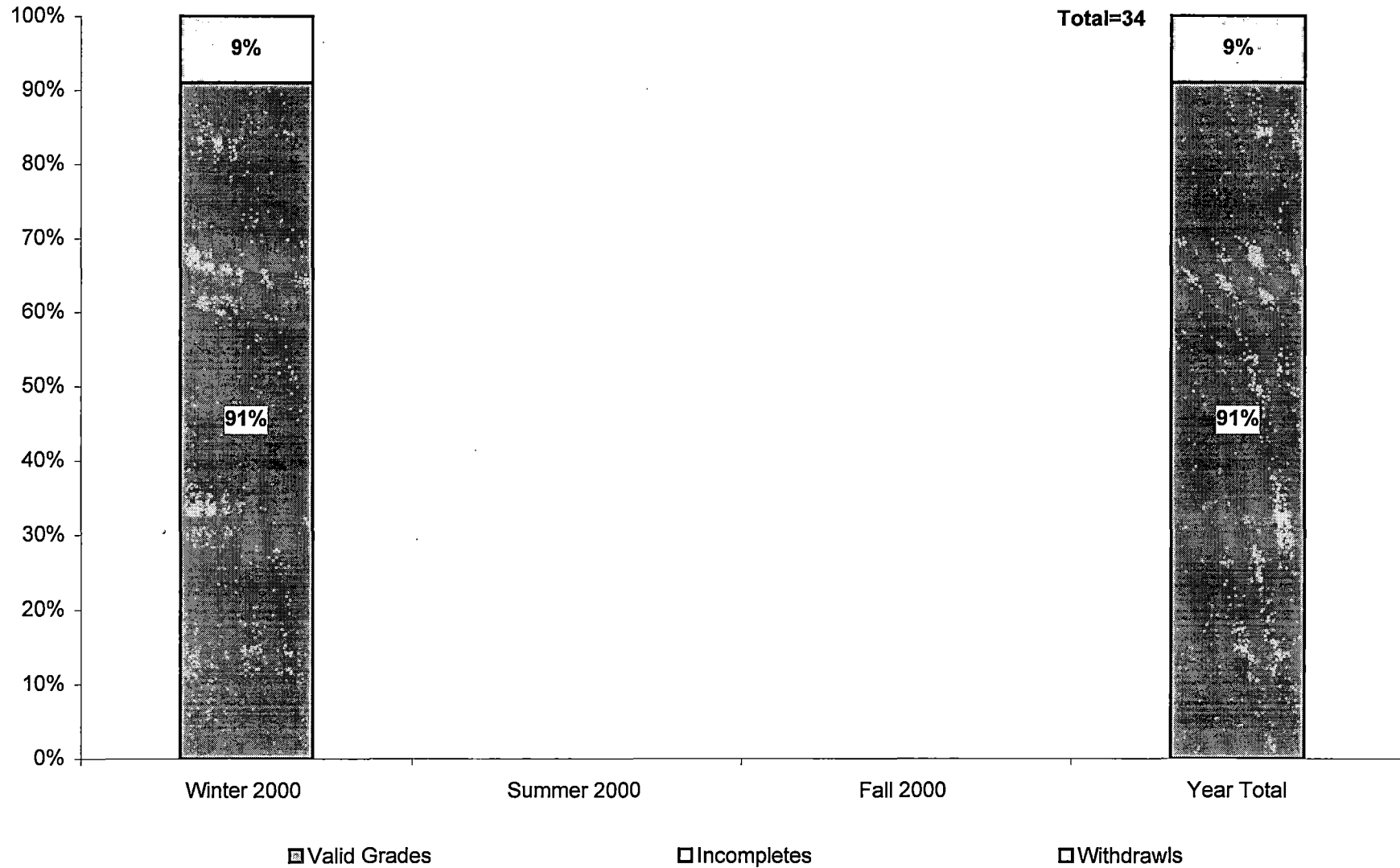

Figure 1.5 LGL 213 (Substantive Law)

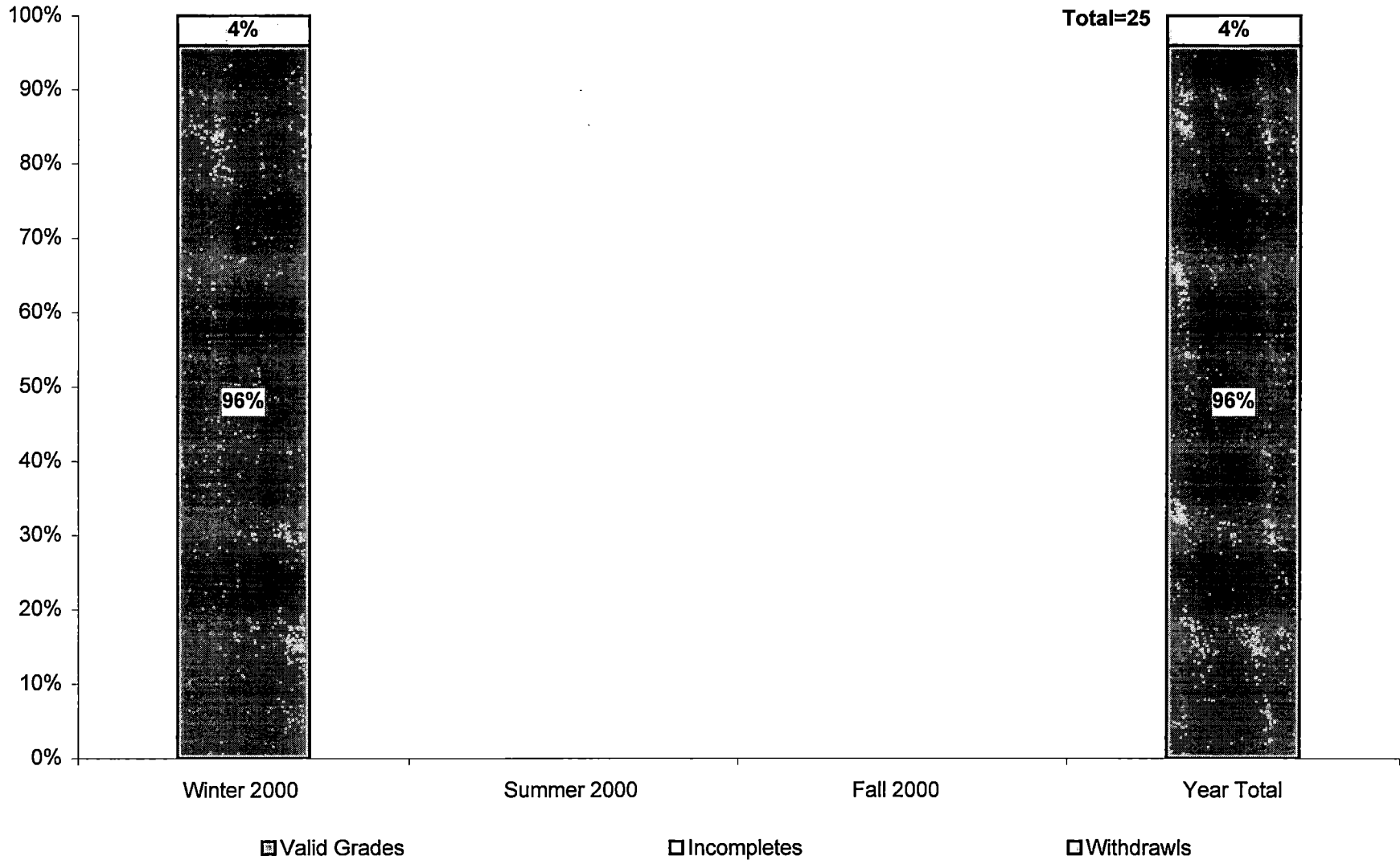

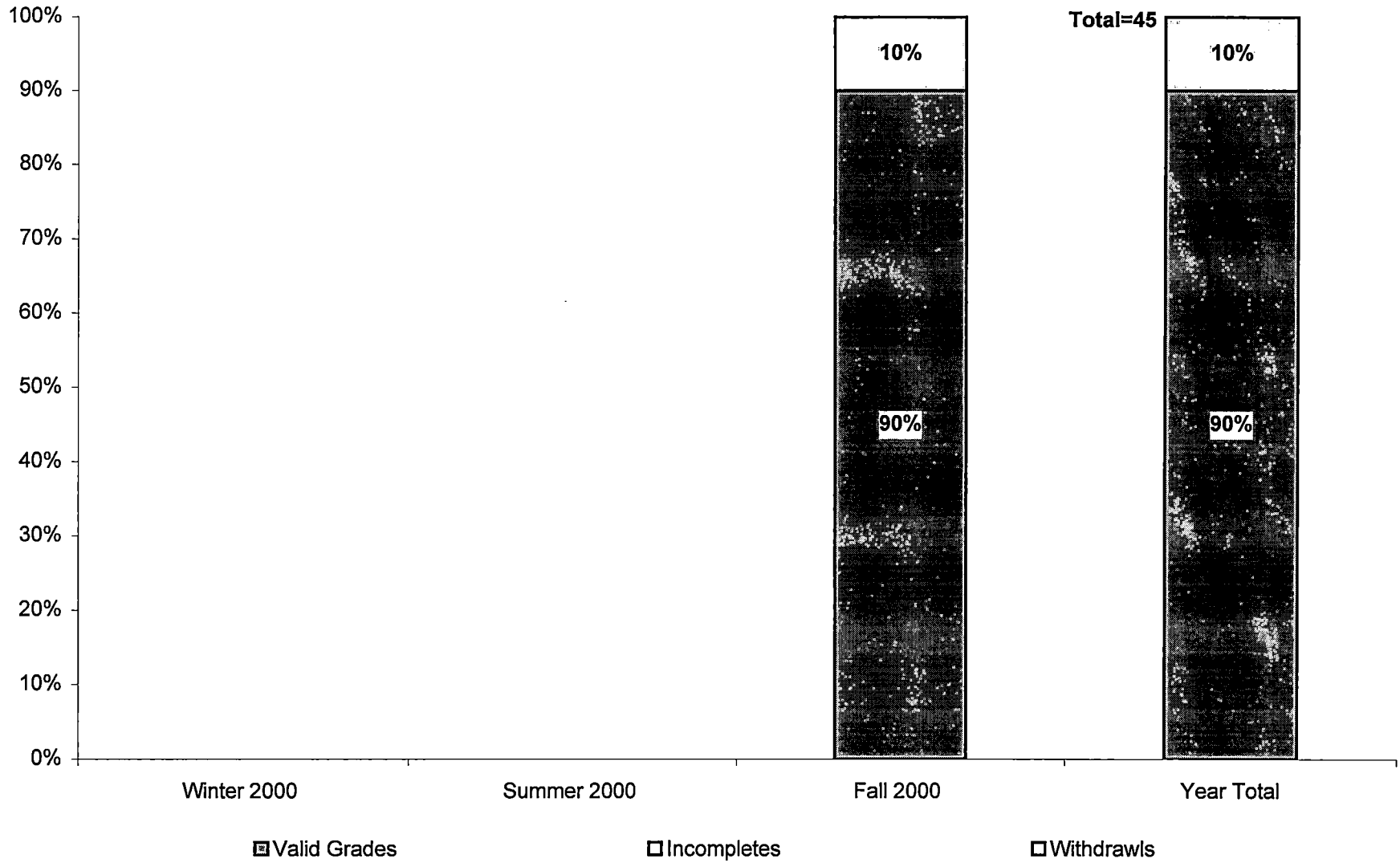


Figure 1.7 LGL 215 (Preparation of Evidence)

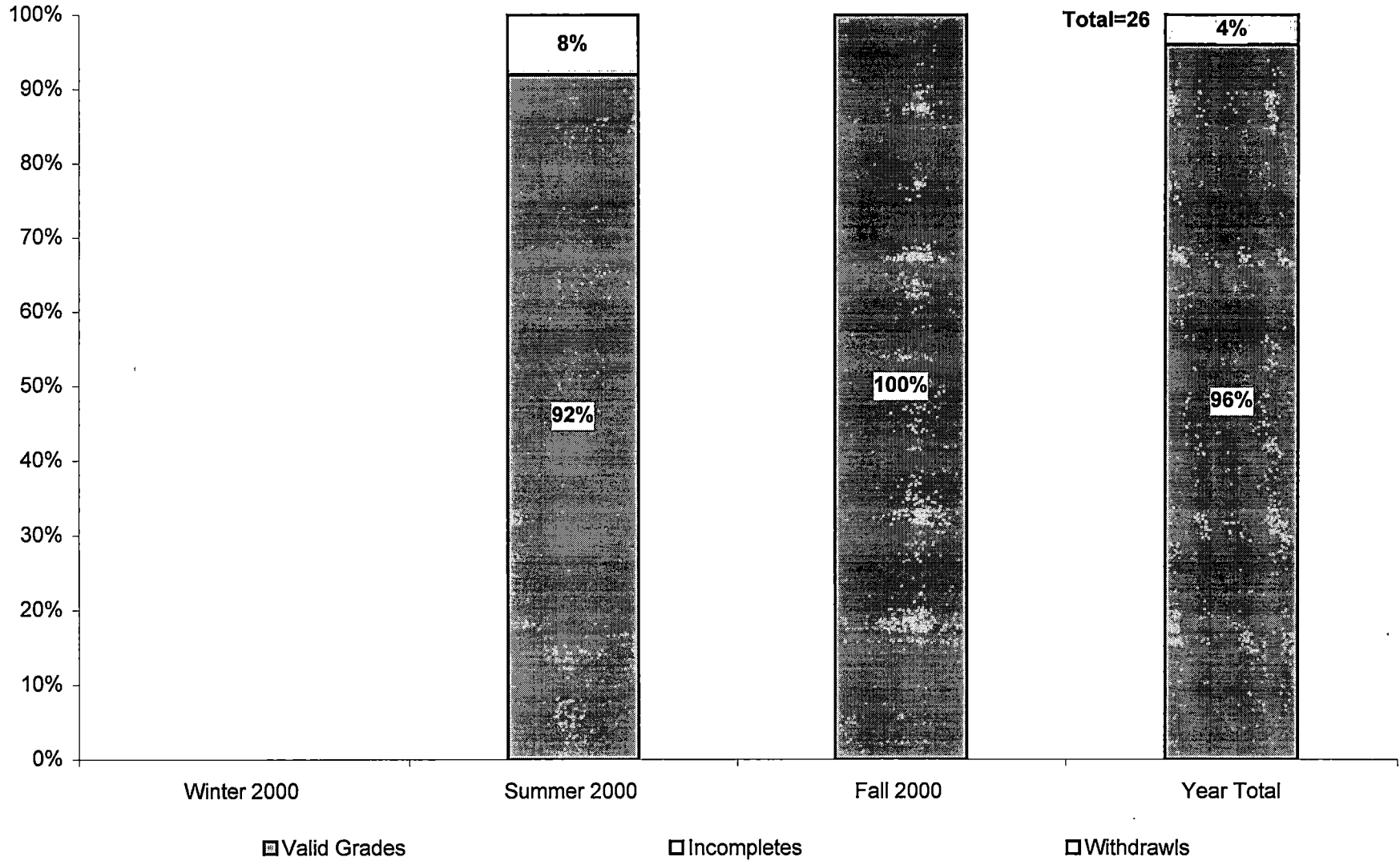

Figure 1.8 LGL 251 (Legal Assistant Internship)

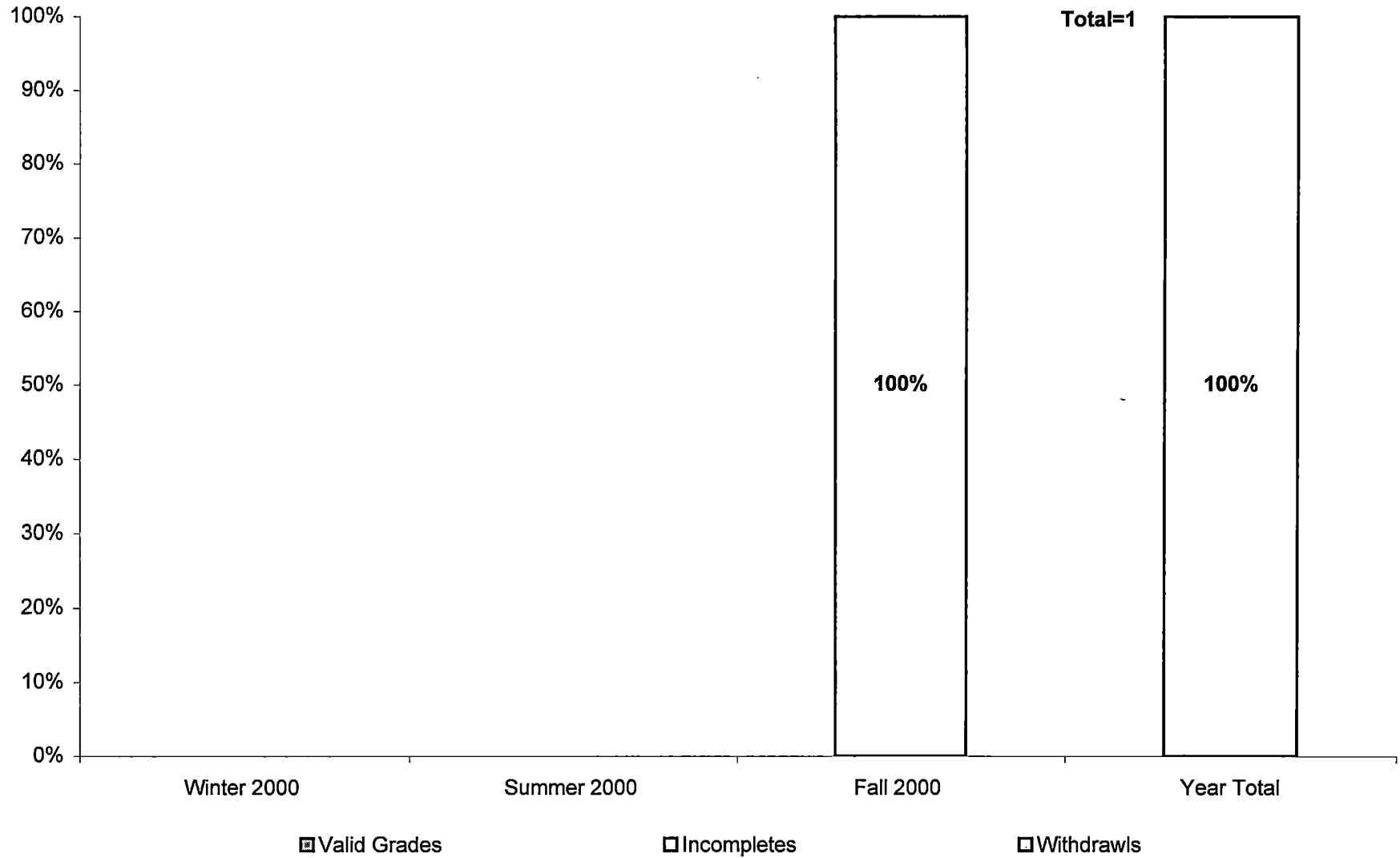

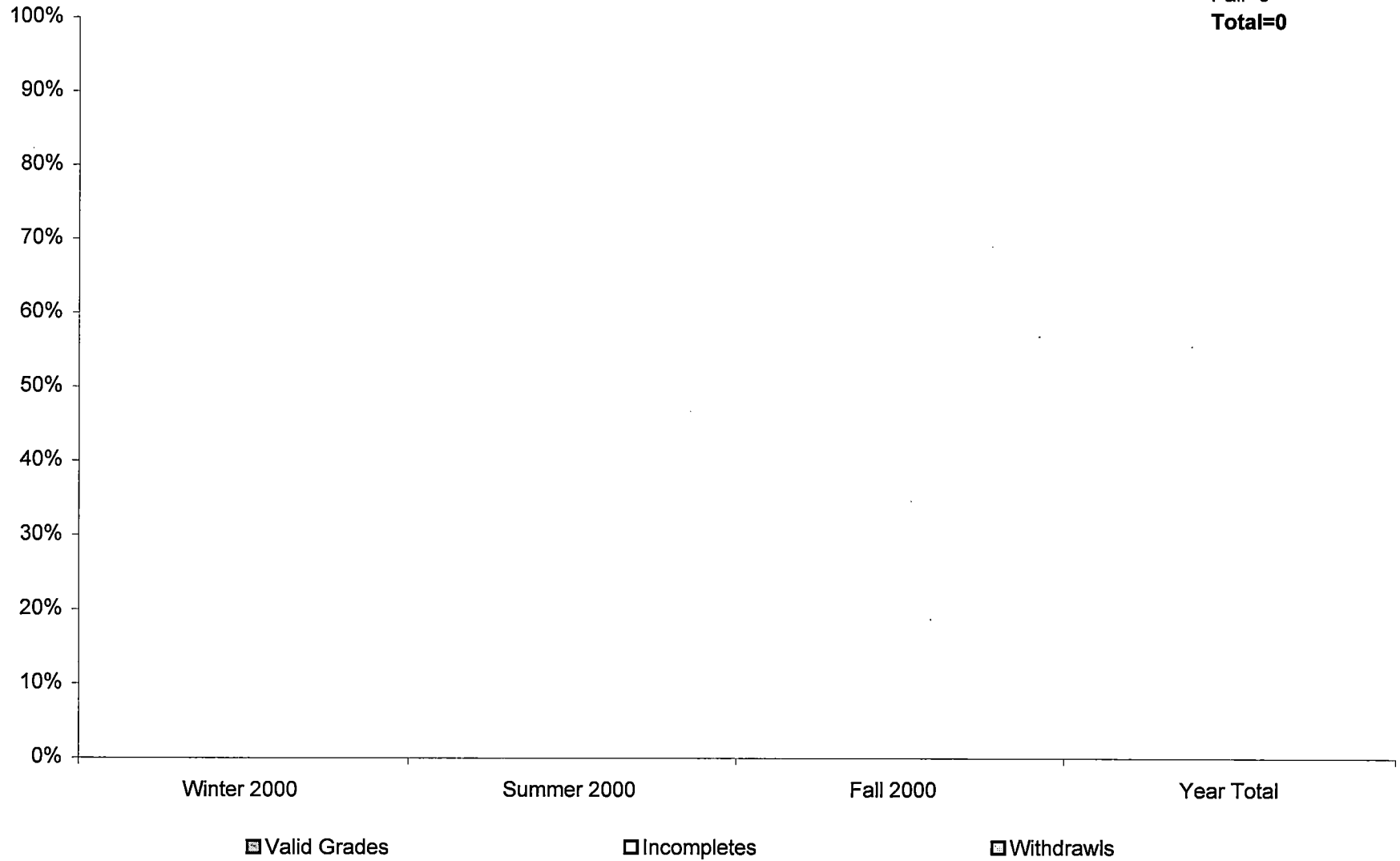

Figure 1.10 LGL 260.3 (Special Topics)

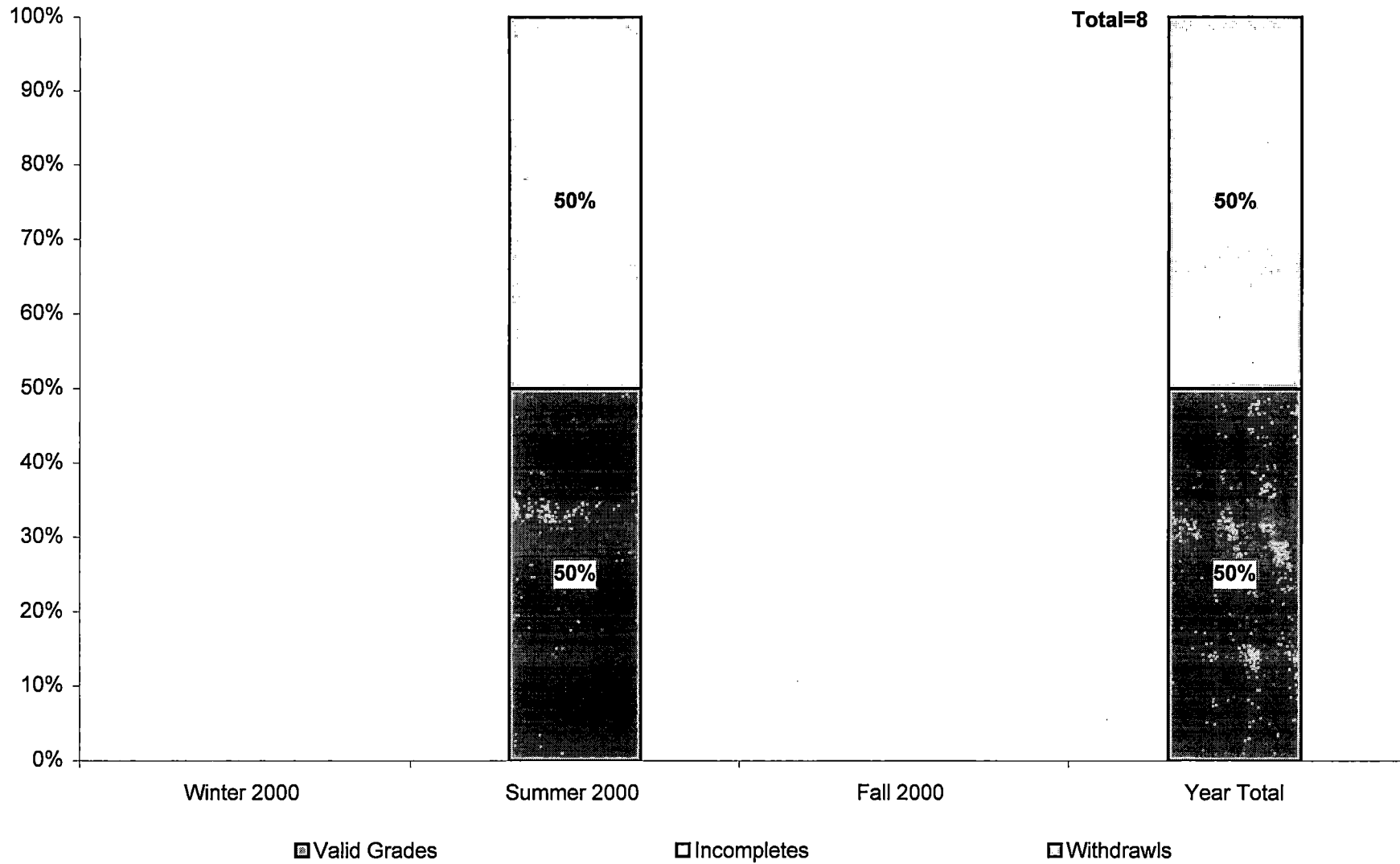

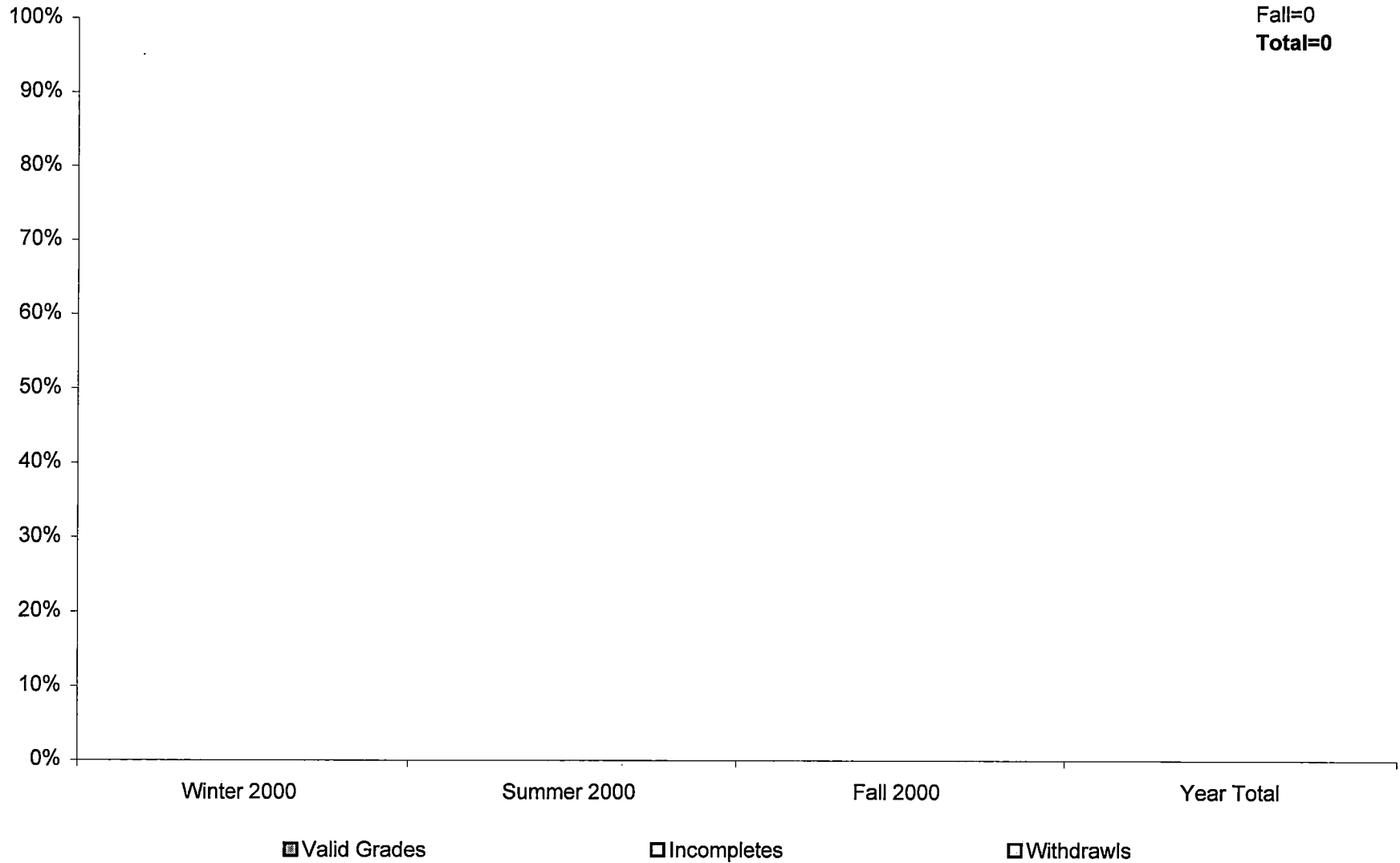

Figure 1.11 LGL 260.5 (Special Topics)

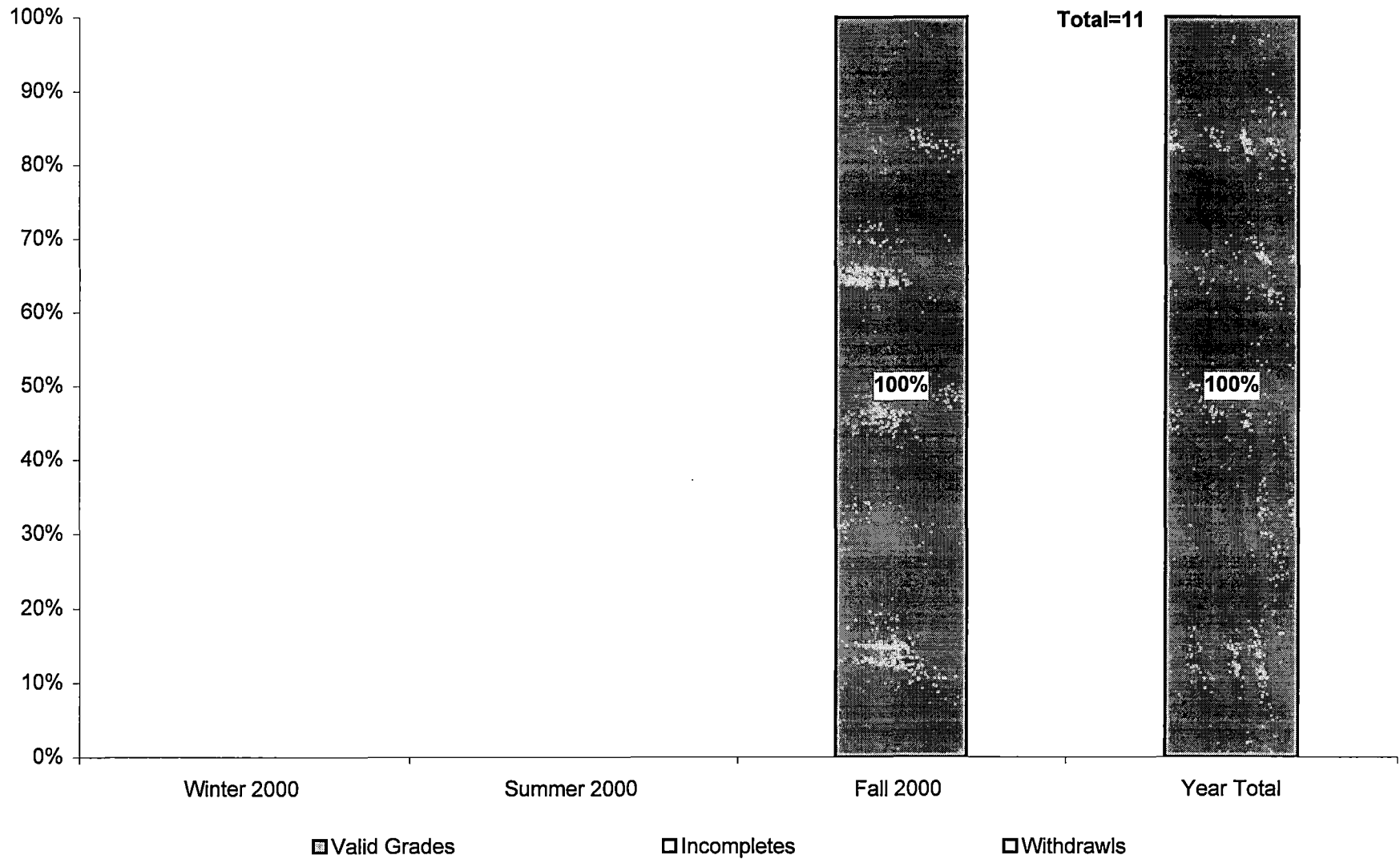

Figure 1.12 LGL 260.7 (Special Topics)

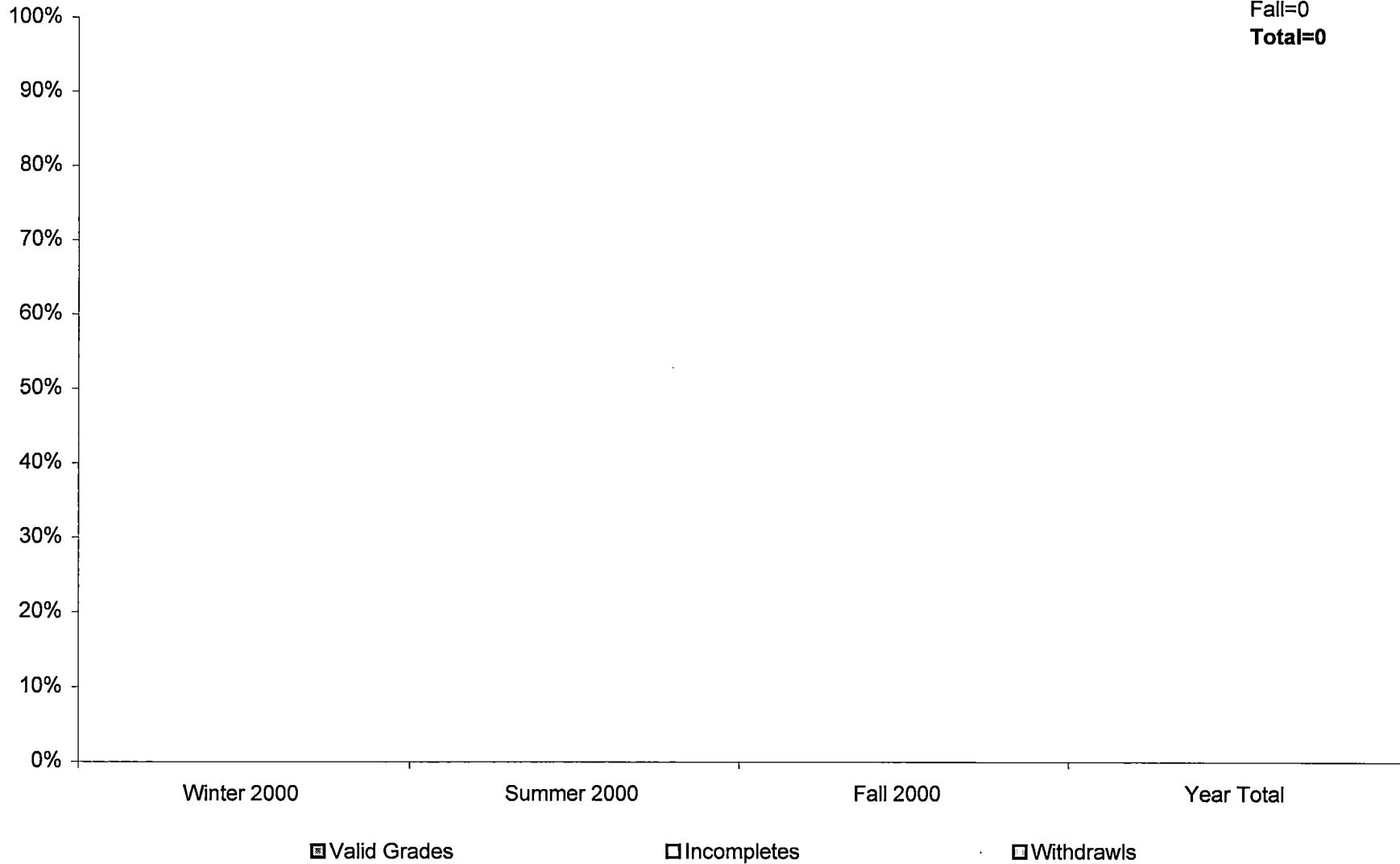
