Please be advised that Eric and I have now heard from many of you regarding pre-PACLoan interlibrary loan statistics. Based on your input the following guidelines are given in the hope that you will be able to comply. The revised grid is attached.

- 1) Please keep these statistics during months of March and April. Return them to me for compilation. The return address is noted on the statistical grid.
- 2) We have omitted unfilled requests from the statistical grid. Too many of you have automated ILL products that will not divulge this statistic.
- 3) All DALNET institutions are requested to keep these statistics. DALNET Access Committee Members and DALNET Project Mangers are being informed of all developments related to PacLoan implementation and the consequent statistical record keeping.
- 4) Due to the feedback supplied, informal monitoring of patron categories and turn around time is not requested since compliance by DALNET institutions is not possible at this time.
- 5) Do you feel that your institution could monitor paid and unpaid requests? It would be helpful to know this information when it comes to actual implementation among DALNET institutions.
- Each institution's policy on turn-around-time could also be helpful to know so that it can be published as part of the promotional material. Most institutions at least try to provide between 24-48 hour turn-around-time because that is what they are hoping to receive in return on their requests.
