## Goals and Objectives

## Goal 1: Member support

Encourage personal and professional development through continuing education, networking, consulting, and responsive communications.

## **Objectives**

- 1.1 By 30 December 2003, create a calendar of continuing education services to facilitate the sharing of expertise among the membership, and to help members develop the skills necessary to thrive in today's complex service environment.
- 1.2 By 30 December 2003, upgrade the DALNET Web site to better support member training and information needs.

#### Goal 2: Innovation

Identify, evaluate, implement, and promote new ways to increase member efficiency and effectiveness, to make DALNET membership a better value and to promote and improve the public perception of libraries in society.

- 2.1 By 30 December 2003, prepare recommendations concerning collaborative projects with neighboring consortia to improve services for our region, and to support statewide resource sharing initiatives.
- 2.2 By 30 June 2004, the Electronic Resources Committee will investigate these potential new services: electronic resource collection development, running electronic database library archiving services, cooperative collection development, joint database purchases, and others identified by the Committee.
- 2.3 By 30 June 2004, the Technology Advisory Committee will investigate these technologies and products with the potential to add value to DALNET: collaborative virtual reference, providing authentication services for members, and others identified by the Committee.

## Goal 3: Resource sharing

Open the door to a new world of ideas, learning and discovery by providing an effective online listing of resources, and by devising creative strategies for enhancing and expanding information access in member libraries.

- 3.1 By 1 November 2003, investigate the integrated library system marketplace and make a determination on whether to migrate to a different ILS.
- 3.2 By 30 December 2003, implement at least three digital projects that provide enhanced access to member information resources.
- 3.3 By 30 December 2003, submit at least one grant proposal for a new DALNET service initiative.
- 3.4 By 30 January 2004, improve access to academic member library collections through reciprocal borrowing arrangements.
- 3.5 By 30 September 2004, provide upgraded integrated library system functionality, including broadcast searching, enhanced content and federated searching.
- 3.6 By 30 September 2004, recruit at least XX new DALNET members.

# Goal 4: Effective Governance

Develop a member-centered organization through effective business practices and responsive communications.

- 4.1 By 30 October 2003, recommend an appropriate host site for DALNET.
- 4.2 By 30 October 2003, devise a new cost allocation formula for implementation in the 2004-2005 fiscal year.
- 4.3 By 30 December 2003, review and revise the DALNET bylaws.
