Database Standards Committee  
Minutes  
March 16, 1988

Members present: Annaclare Evans, WSU, chair; Kathy Vredevoogd Botsford General Hospital; Helen Ma, Rex Dotson, Detroit Public Library; Ann Pogany, Oakland University; Theresa Shen, Wayne County Community College.

The meeting was called to order by Annaclare Evans at 9:45 a.m. in the WSU Purdy Library.

Filing indicators: Annaclare Evans stated that problems with filing indicators at Wayne need to be fixed manually. It is more difficult to handle the indefinite article than the definite one. Since NOTIS will only give an index of bib screen and will not generate a report of filing indicators, it is necessary to call the bib record out and fix the filing indicators individually. (e.g. searching filing indicators: The a, The b, le a, la a, etc.) She further stated that BNA will fix both English and foreign language indicators, and that NOTIS will only fix English indicators.

Duplicate authority records: Annaclare pointed out that WSU has had less than 5% of duplicates of new additional authority records as of Feb. 27, 1988. WSU had loaded 3,510,00 microcon records into NOTIS of which 10,000 records were loaded because they were either serials or duplicates, and they needed further verification.

Subject authority records: Annaclare said that WSU had reopened the agenda of loading subject authority tapes. Ann Pogany stated that subject headings search in subject authority records in NOTIS is time consuming. It is hard to tell the desired heading that a patron wants because the system lists searched subject headings as well as their related cross references.

Indexing problems: Annaclare said that subject headings are cumbersome and that member libraries should document the problems and send printouts to her.

Processing cost of Authority records by BNA: Helen Ma provided the following information:

2 /Bib/name & series  
2 /Bib/subject  
2 /Bib/create authority record  
.0025 /Bib./ put authority records on tape  
\$20.00 /tape

Authority tapeload records - BNA checks authority records against DALNET file. If there is no finding, BNA will check authority records against LC authority file.

Subject authority file: It was suggested to buy LC tapes and load them into NOTIS.

Subject authority policy statement: WSU will do post-cataloging verification of subject authority records submitted by member libraries. Annaclare will add "LC" to policy statement.

Subject headings search: Annaclare suggested member libraries to leave both LC, Mesh, or children headings on records. Therefore, the patron can access records by various headings.

Documents - GPO Tapes: DPL, WSU, OU are interested in loading GPO tapes into NOTIS.

Others: Annaclare stated that at next meeting she will focus on subject, name and series authority records. Theresa Shen volunteered to briefly draft standards for minimal level records.

Meeting adjourned at 11:45 a.m.

Next meeting will be held from 9:30 -12:00 a.m. on April 21, 1988 at Purdy Library, WSU.
