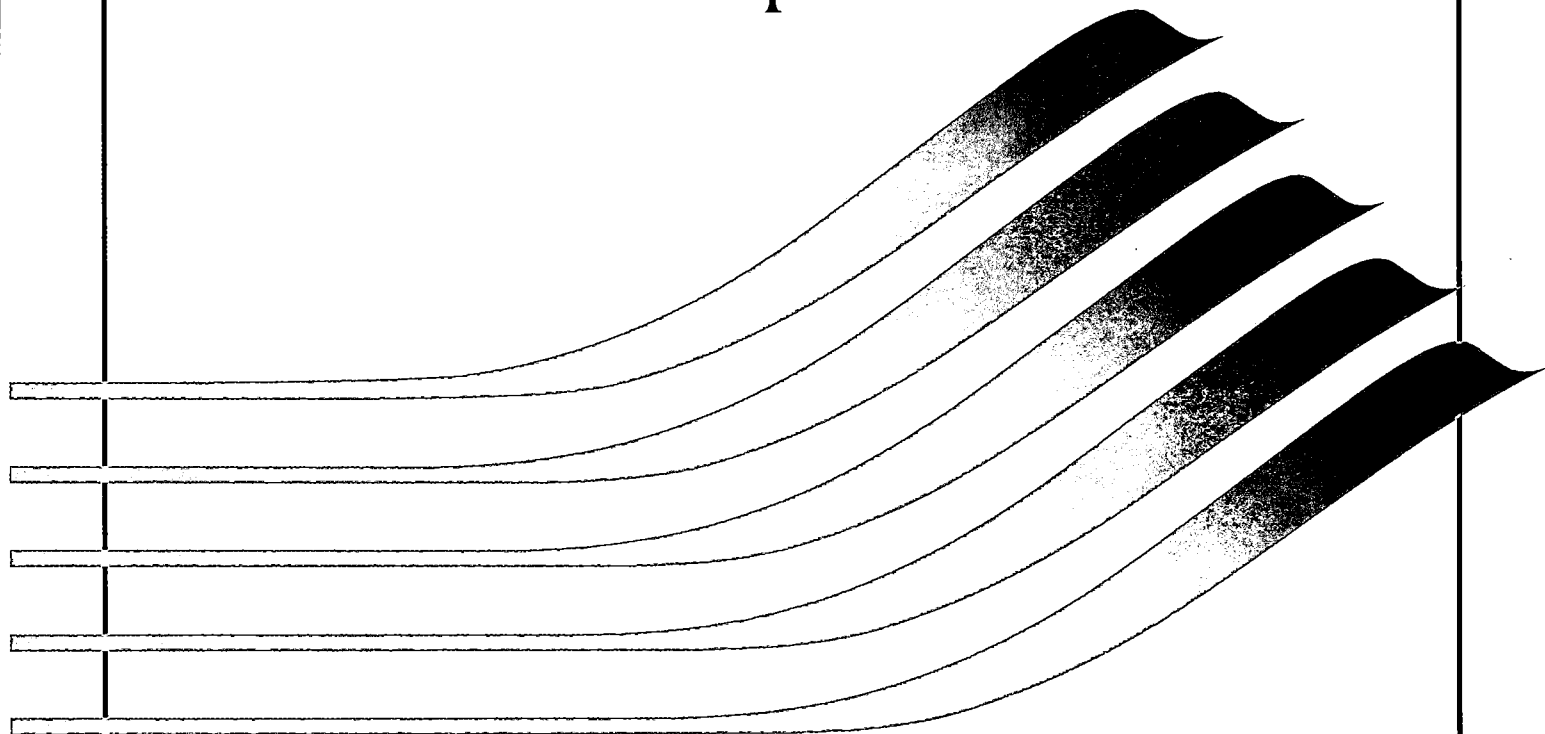
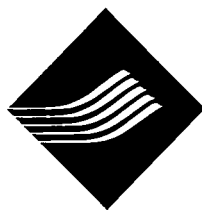

OFFICIAL ENROLLMENT WINTER 2005, FIRST DAY OF SESSION REPORT EXECUTIVE SUMMARY

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. Please note that Institutional Research has added a section indicating high and low enrollment figures for First Day of Session data over the past ten years.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

This report can be summarized with the following main points:

- The number of College-Wide Student Credit Hours has experienced a decrease of 2.4% when compared with the same time period last year. In contrast, over the five-year period (2001 to 2005), total Student Credit Hours increased 15.0%.
- Student Headcount at the college-wide level has decreased by 3.3% since 2004. However, over the five-year period, headcount increased by 8.2%.
- College-wide Credit Hours per Student (8.12) have increased slightly (.9%) since last year, while over the five-year period, this figure has increased by 6.3%.

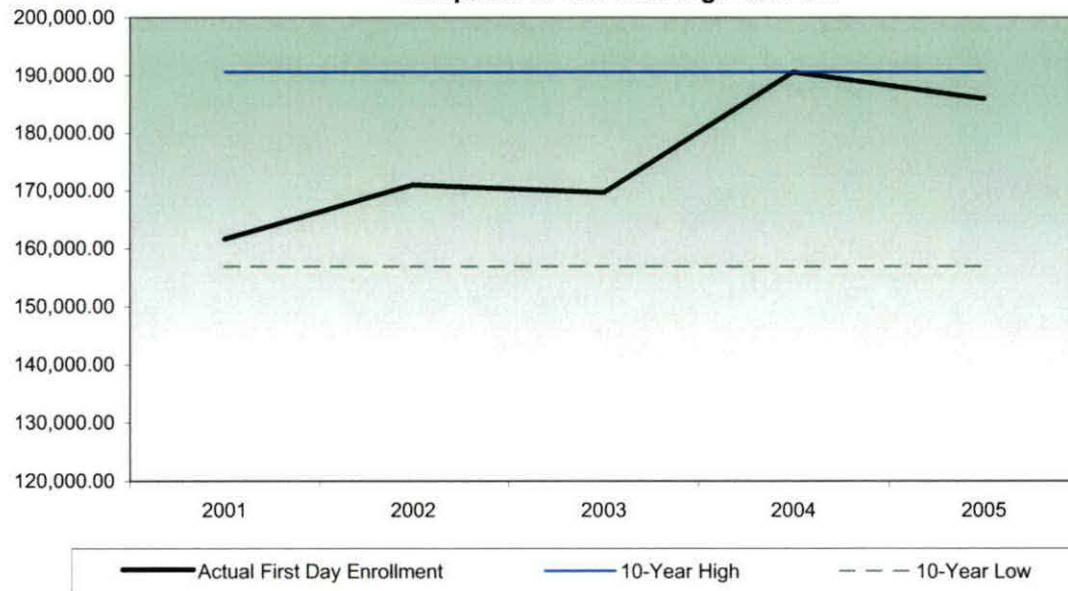
Overall, compared to the same figures one year ago, there were decreases in College-Wide Student Credit Hours and Student Headcount (2.4% and 3.3%, respectively), while Credit Hours per Student rose slightly (.9%).

EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit and non-credit hours; 2) total student headcount; and 3) the number of credit hours per student; as well as projections college-wide and by campus.

All individual campus Student Credit Hours and Headcounts can be found in the Credits Per Student tables.

This report can be summarized with the following main points:

- The combined number of College-Wide Student Credit and Non-Credit Hours has increased by 3.7% when compared to the same time period one year ago. Over a five-year period (2001-2005), combined Credit and Non-Credit Hours decreased by 5.6%.
- At the College-Wide level, Student Headcount experienced an increase of 1.5% compared with the same time period last year, while a decrease of 3.6% in Student Headcount is noted over the five-year time period.
- Compared with the previous year, College-Wide End of Session Credit Hours per Student increased by 2.2%. However, over the five-year period, there was a decrease of 2.1% in Credit Hours per Student.

Overall, compared to the previous year, there were increases in all areas: Student Credit Hours (credit and non-credit), Student Headcount and Credit Hours per Student. Conversely, over the five-year period, Student Credit Hours, Student Headcount and Credit Hours per Student each declined.

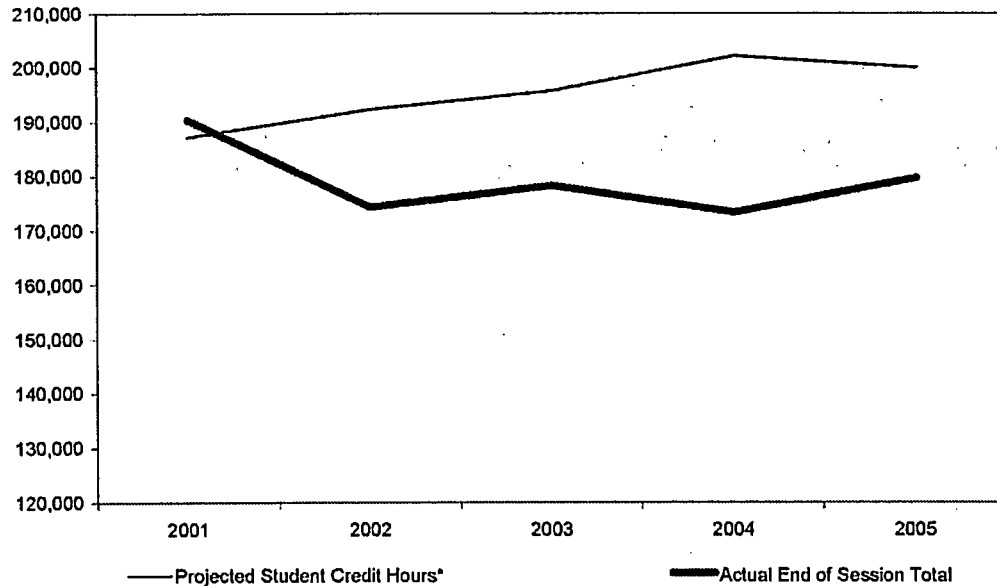

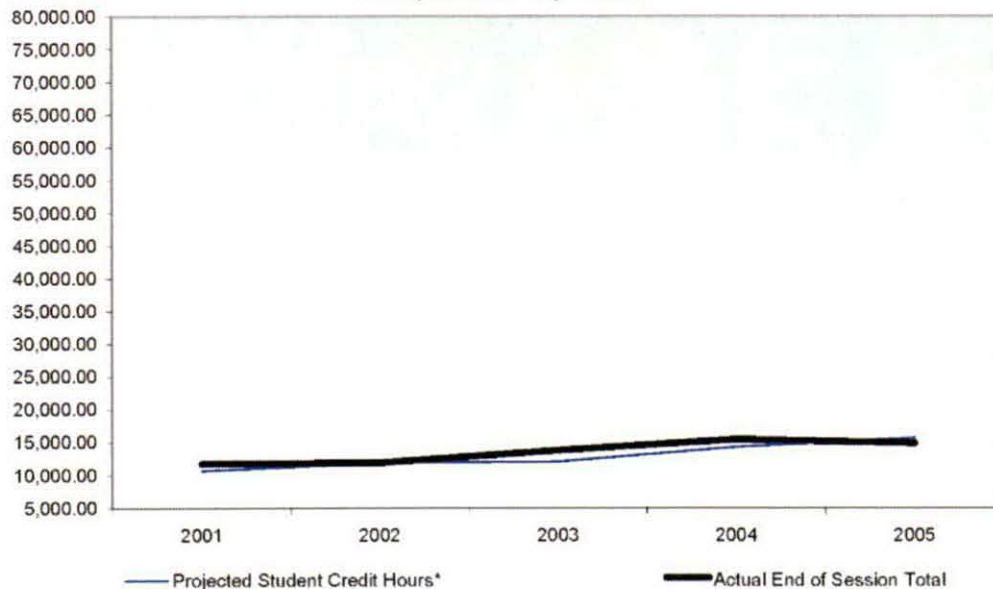

Credit Hours Per Student Ratio



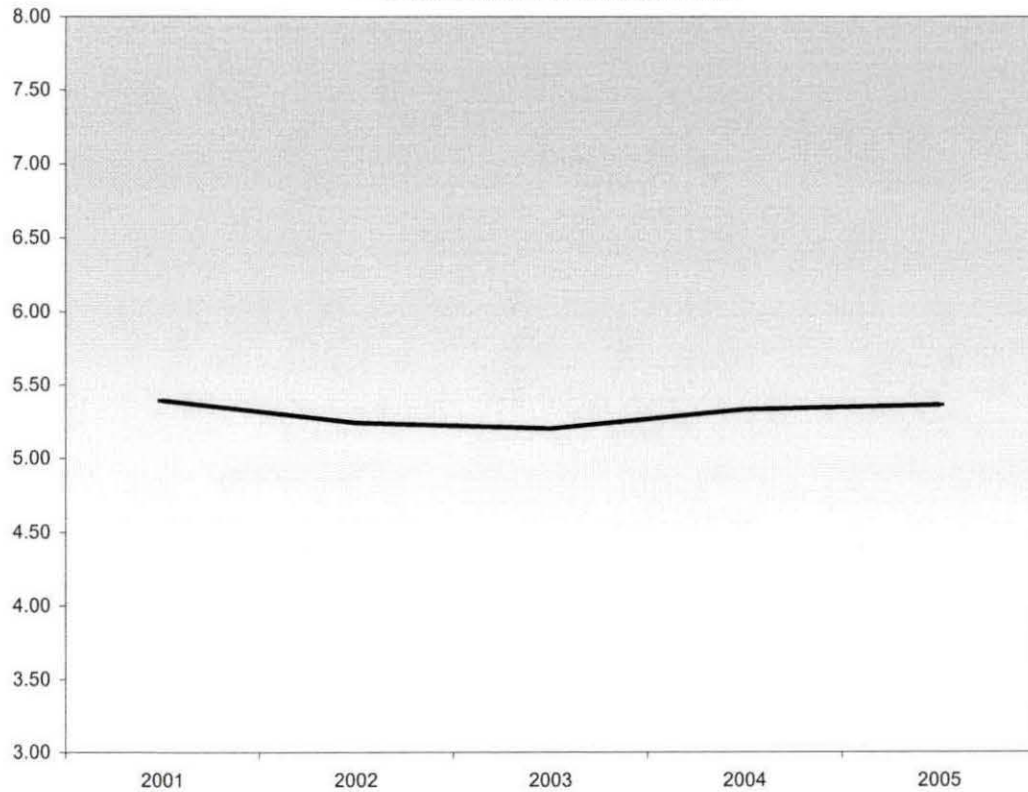

Credit Hours Per Student Ratio



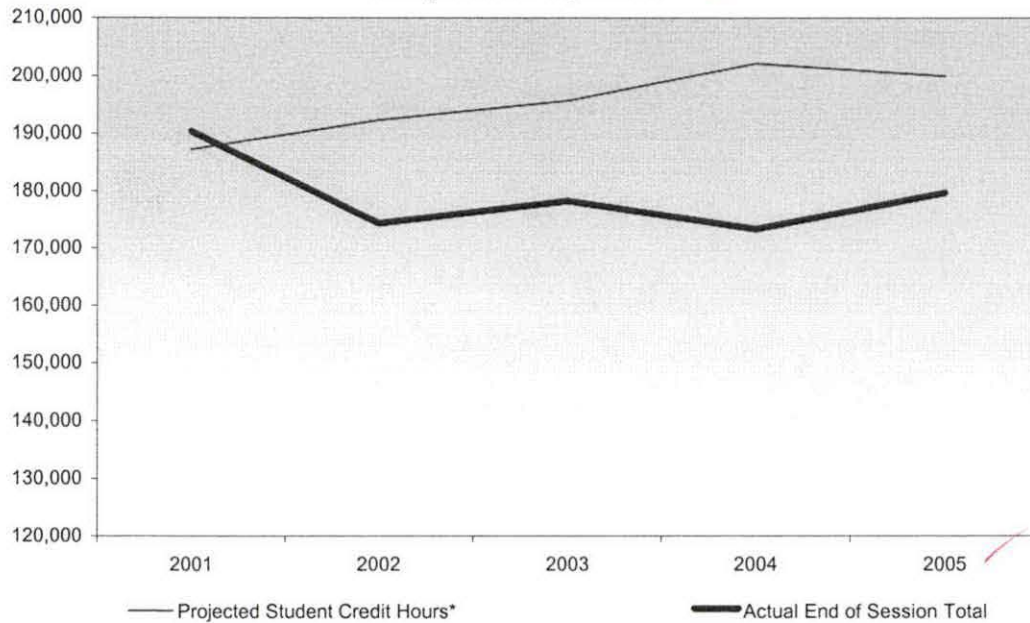
