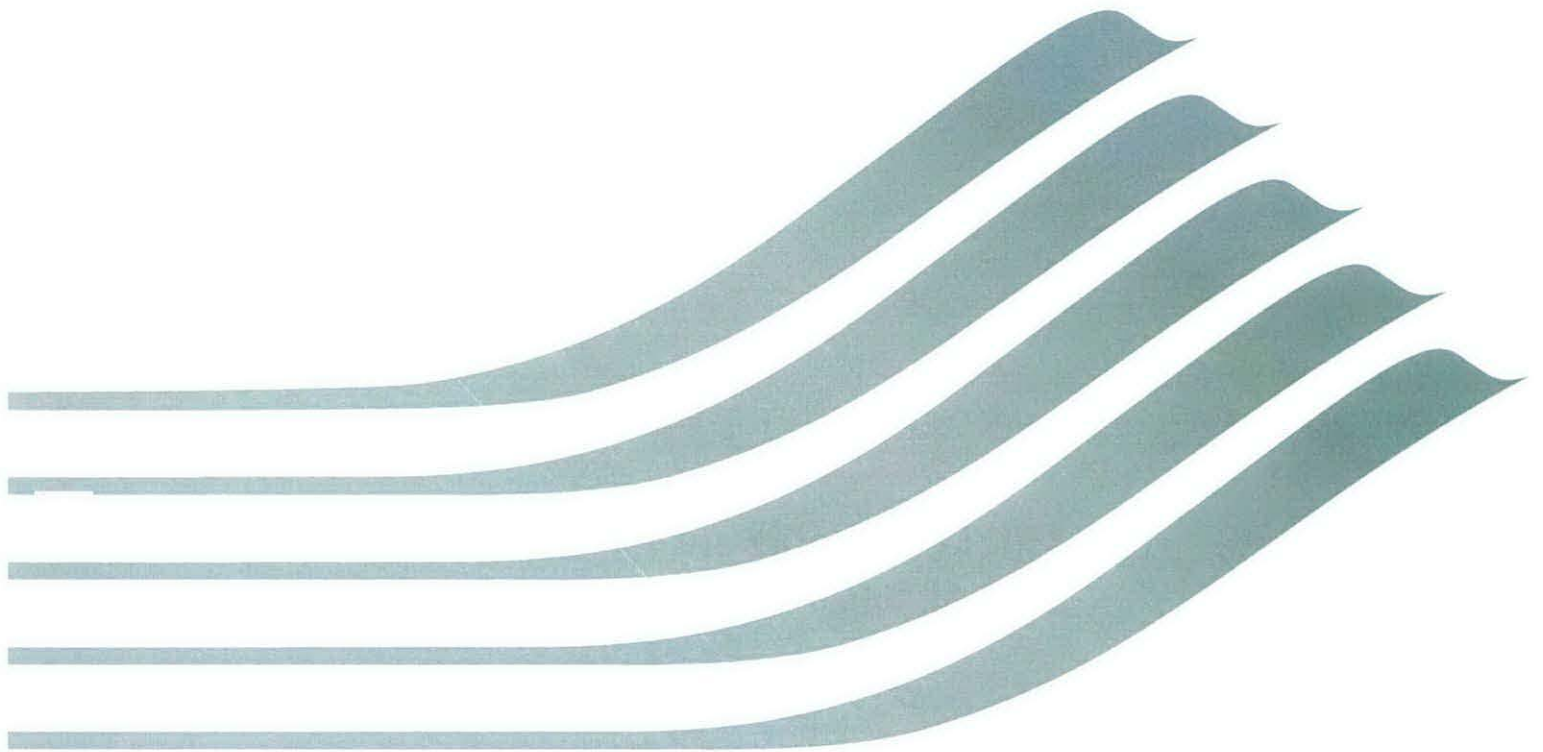

OFFICIAL ENROLLMENT FALL 2012, END OF SESSION REPORT EXECUTIVE SUMMARY

The following report contains data related to: 1) the number of student credit and non-credit hours; 2) total student headcount; and 3) the number of credit hours per student; as well as projections college-wide and by campus.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

In brief:

- The combined number of College-wide Student Credit and Non-Credit Hours (207,151.05) **decreased** by 5.3% when compared to the same time period one year ago. Over a five-year period (2008-2012), combined credit and non-credit hours **increased** by 9.5%.
- College-wide Student Headcount (27,473) **decreased** by 4.8% from last year, and **increased** by 10.7% over a five-year time frame.
- College-wide End of Session Credit Hours per Student (7.54) **decreased** by 0.5% from last year. Over the five-year period, Credit Hours per Student **decreased** by 1.2%.

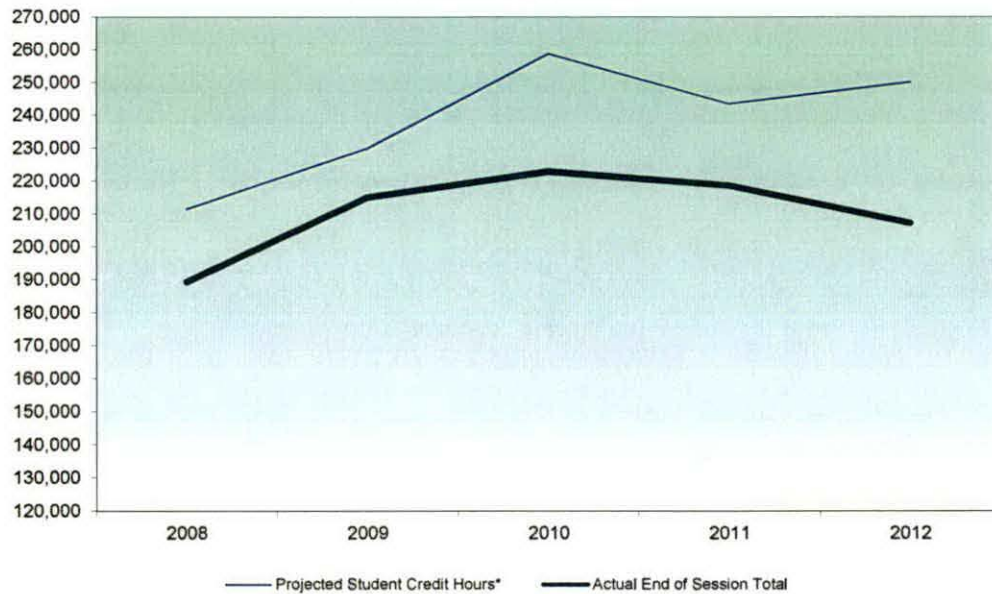

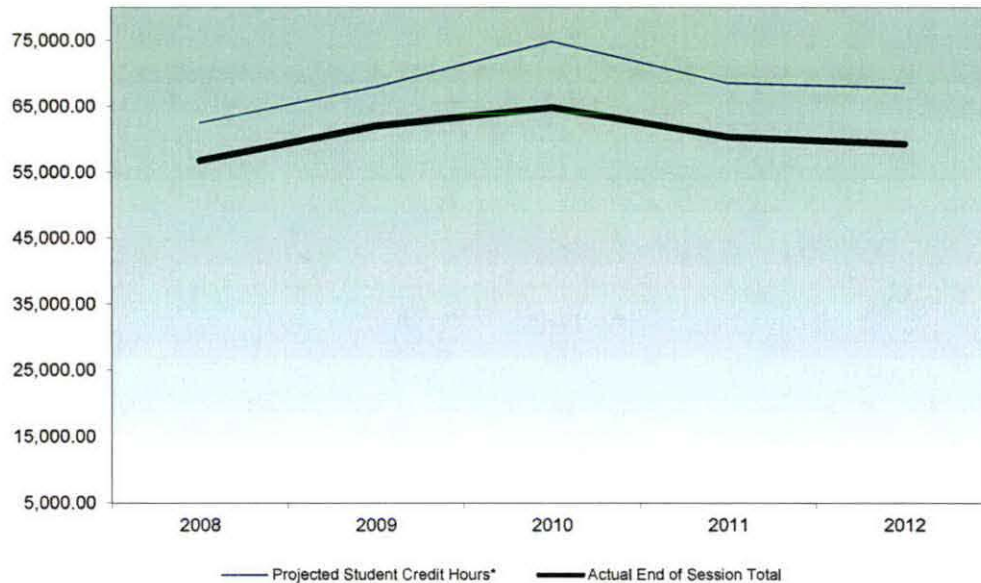

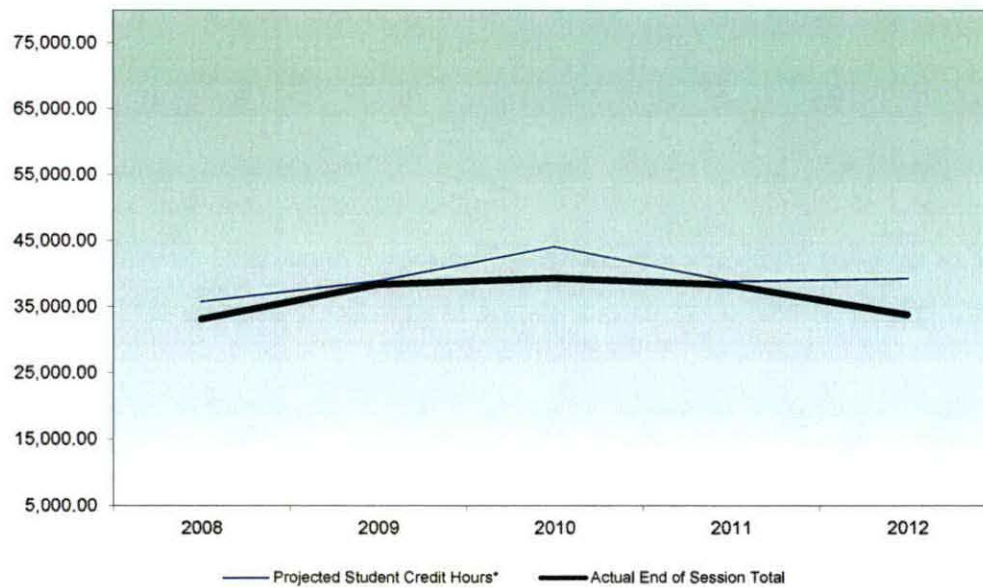

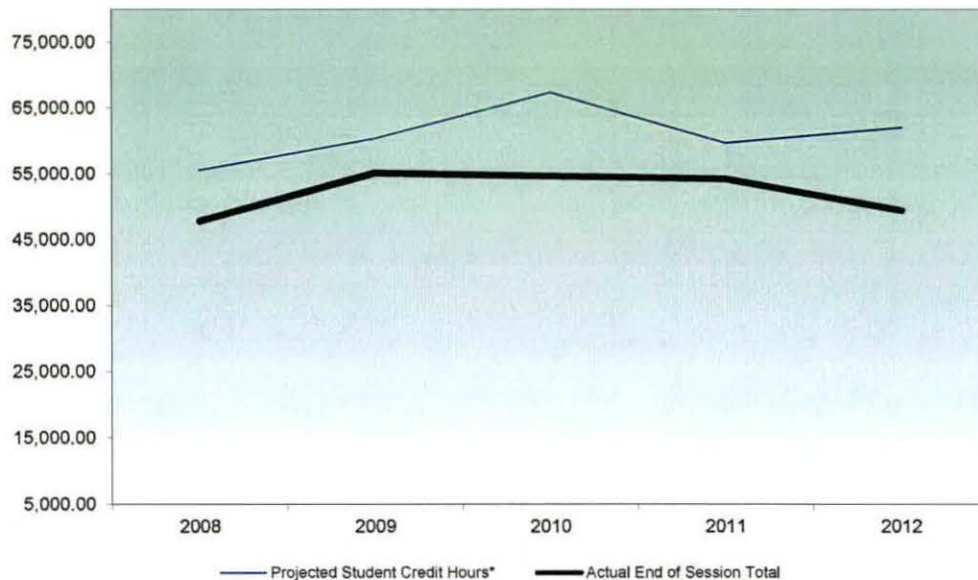

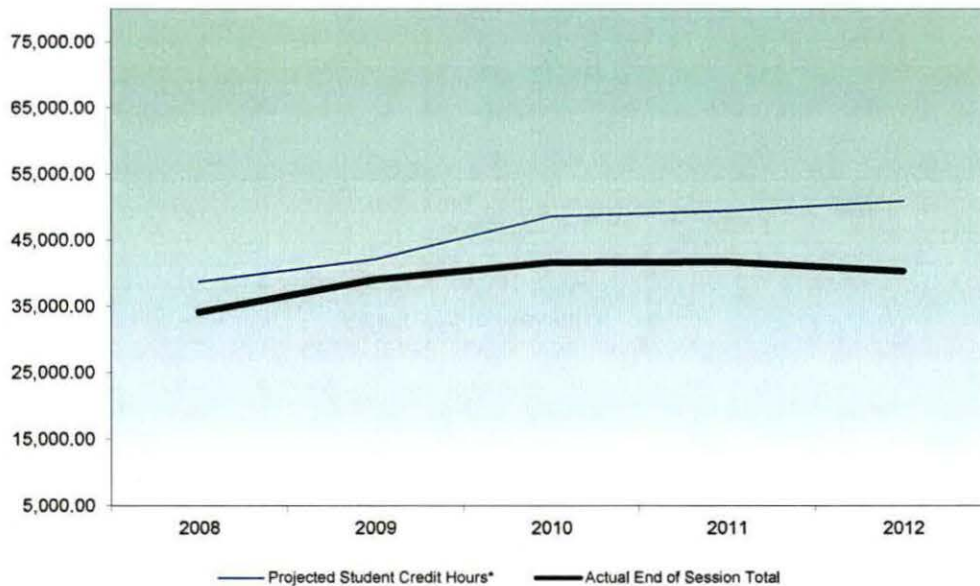

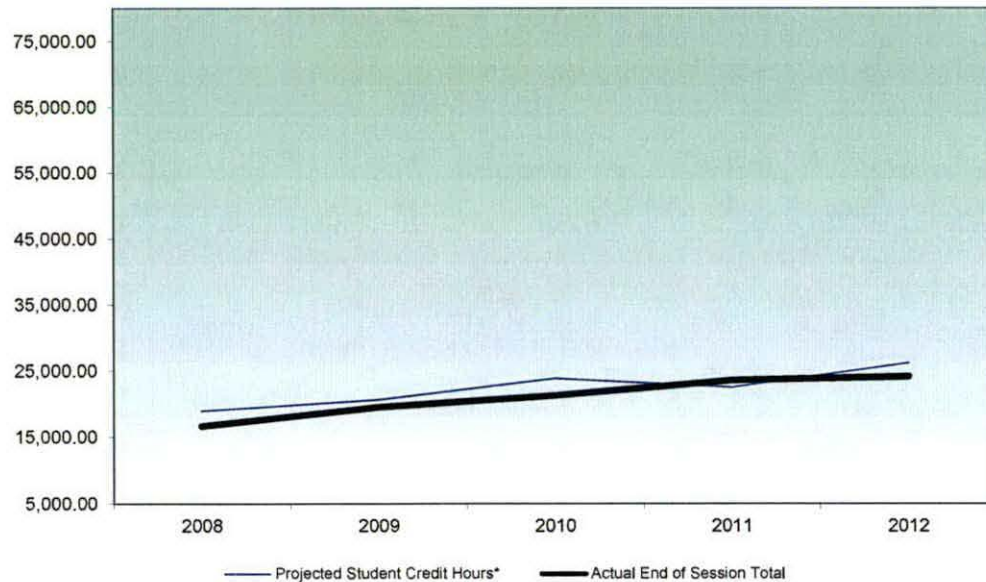

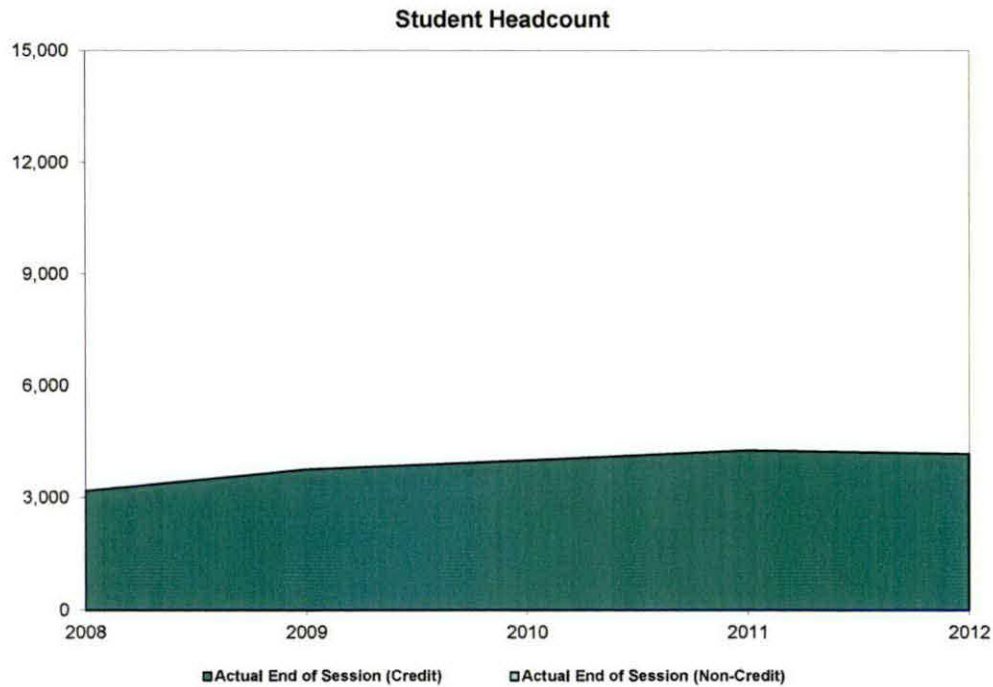

OFFICIAL ENROLLMENT FALL 2012, ONE-TENTH DAY OF SESSION (9/11/2012) REPORT EXECUTIVE SUMMARY

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. Institutional Research has added a section to the One-Tenth Day Report that compares College-Wide One-Tenth Day enrollment figures with First Day of Session figures for the same term.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

- College-Wide Student Credit Hours (234,885.50) **decreased** by 6.9% when compared to the One-Tenth Day last year (Fall 2011). Over the five-year period (2008 to 2012), total Student Credit Hours **increased** 11.1%.
- College-Wide Student Headcount (27,503) **decreased** 6.0% from last year, and **increased** 10.2% when compared to Fall 2008.
- College-Wide Credit Hours per Student (8.54) **decreased** 0.9% since last year, and has **increased** 0.8% from Fall 2008.

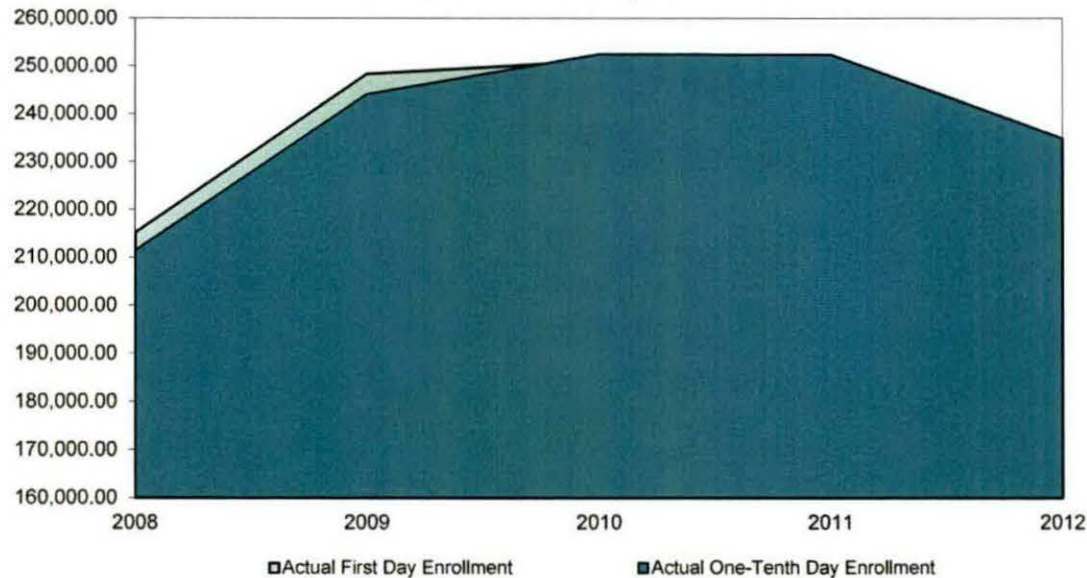
In summary, credit hours and headcount decreased over the one-year period, while over the five-year period, increases are noted in both areas. There was a very slight decrease in credit hours per student since last year, with a small increase reported over the five-year figure.

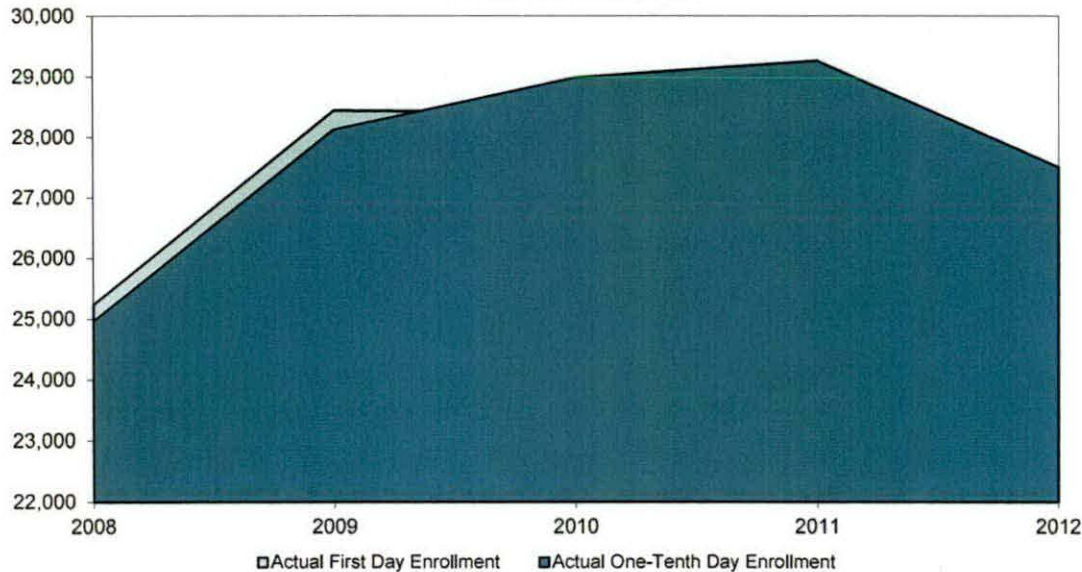

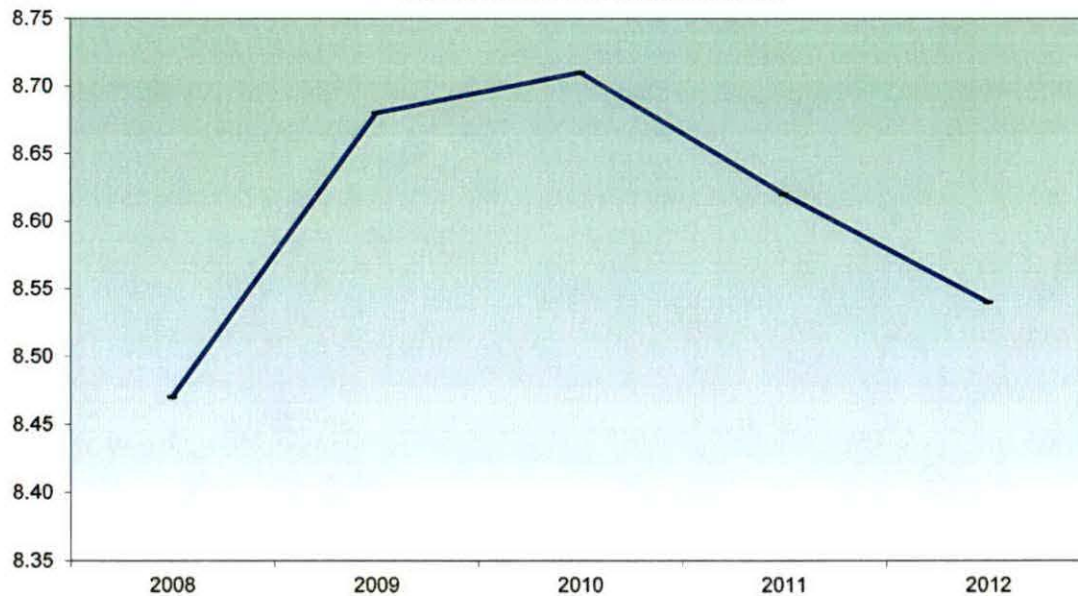

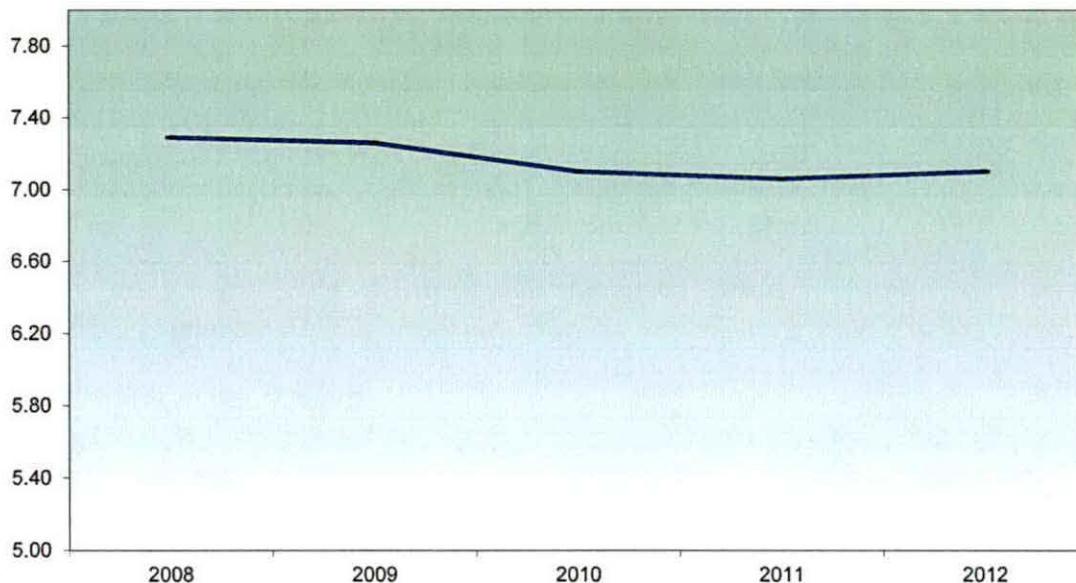

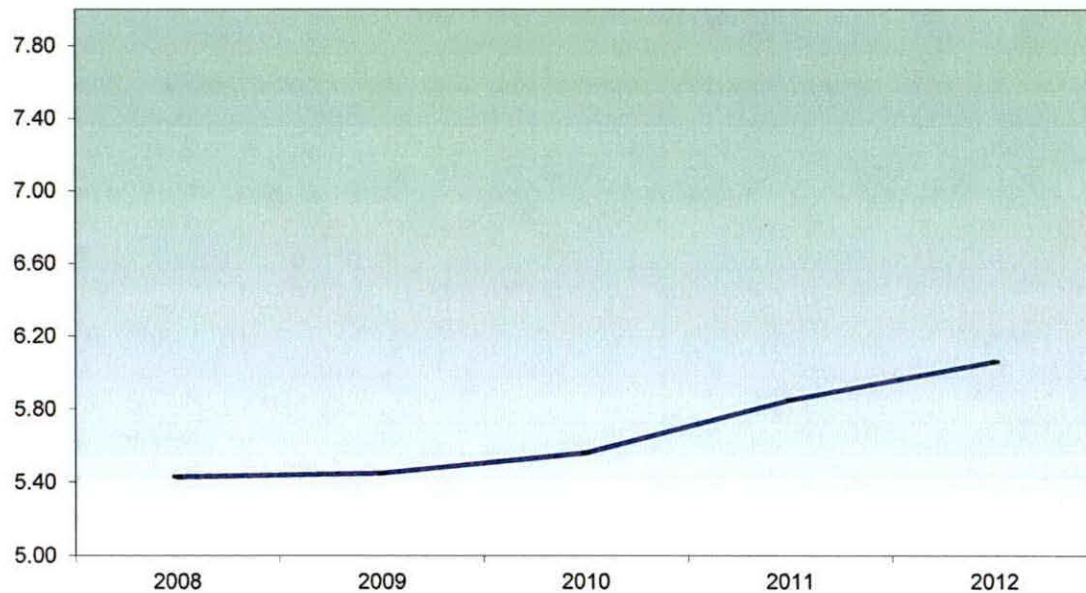

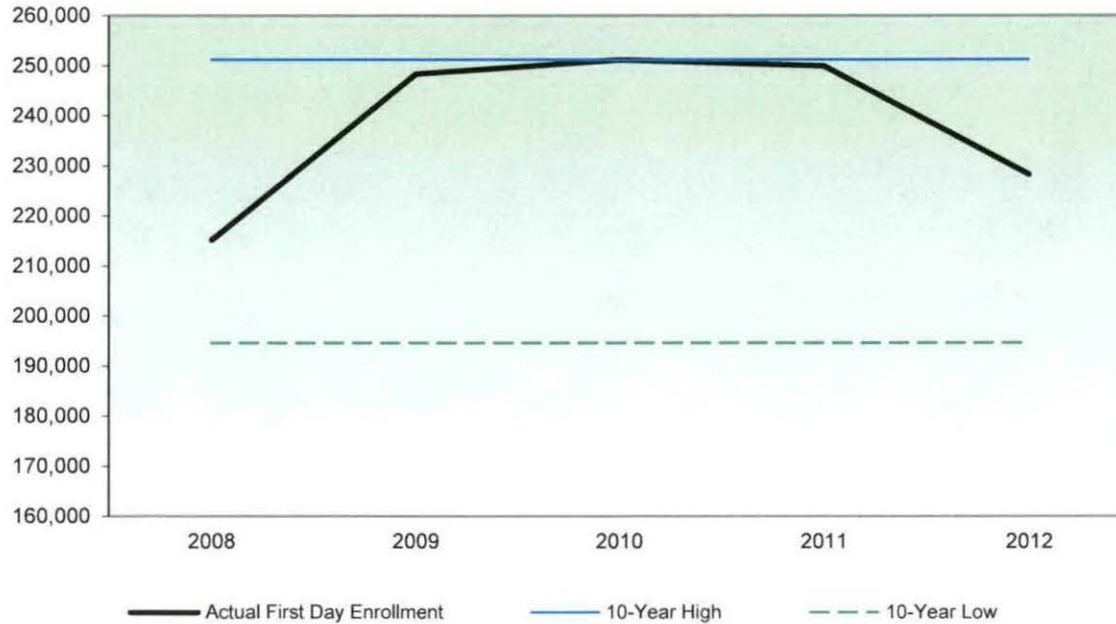

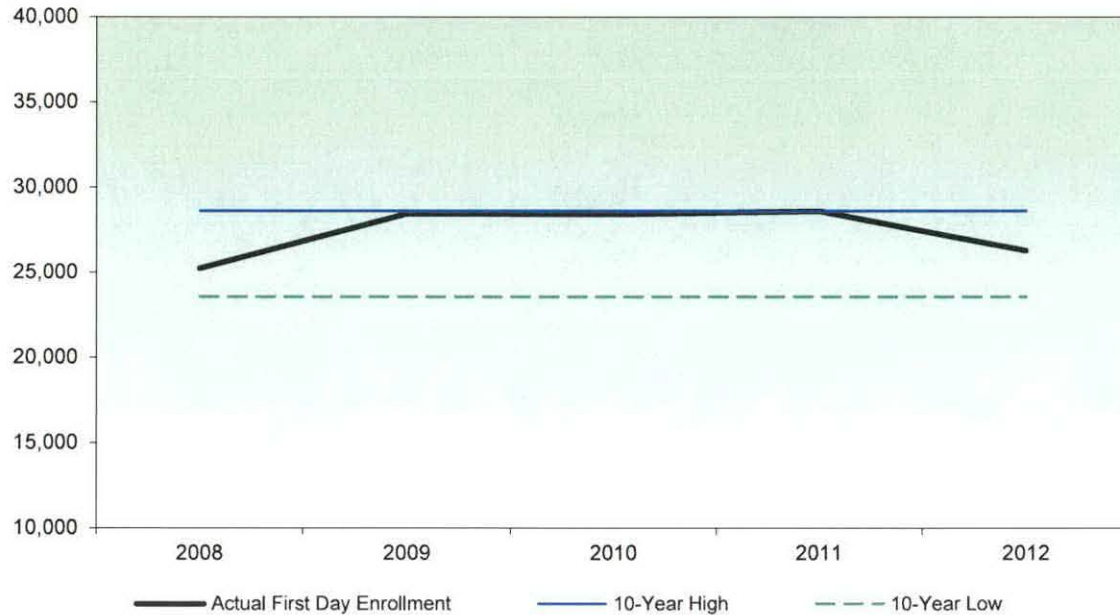

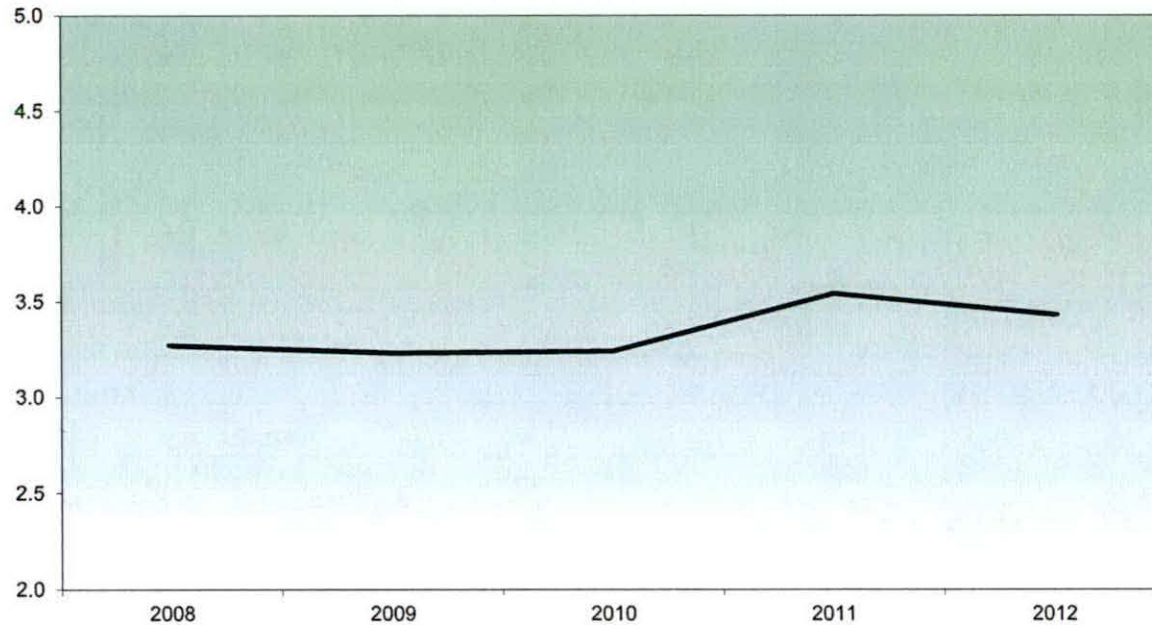

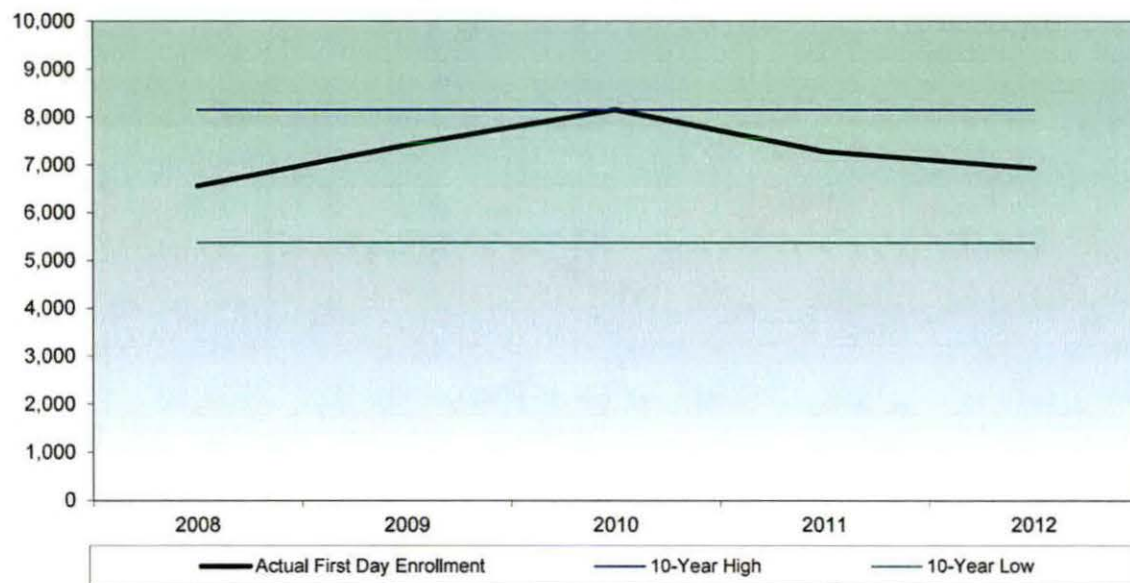

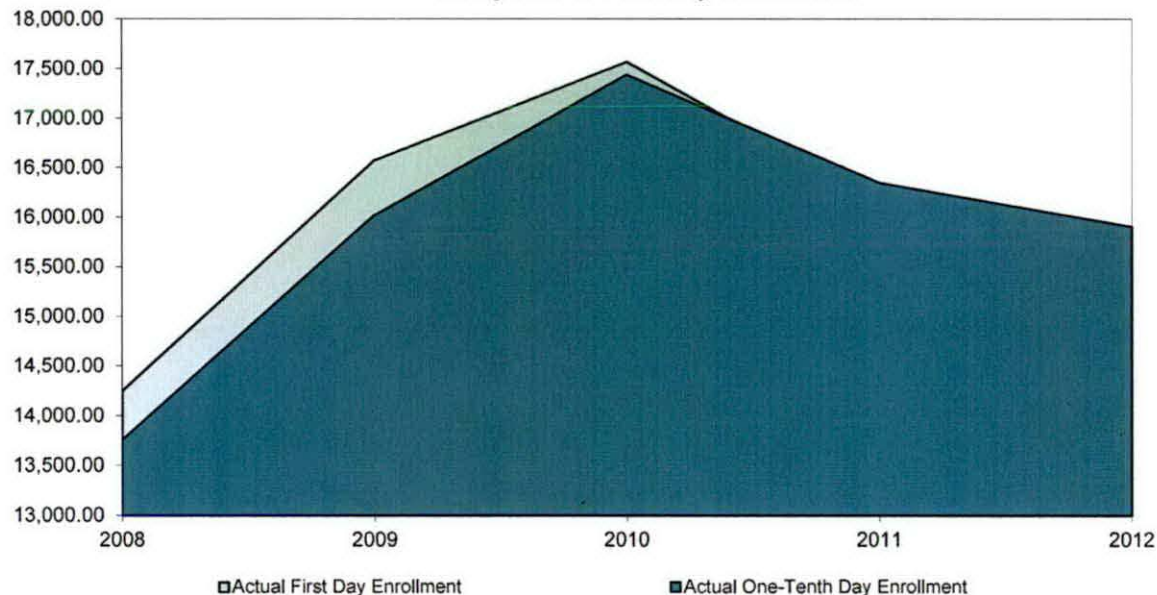

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

- College-wide Student Credit Hours (84,636.00) has **decreased** by 4.2% when compared with the same time period last year. Over the five-year period (2008 to 2012) total Student Credit Hours **increased** by 18.9%.
- College-wide Student Headcount (15,582) **decreased** 3.5% since 2011, and **increased** 9.4% over the five-year period.
- College-wide Credit Hours per Student (5.43) **decreased** 0.7% since last year. Over the five-year period, this figure has **increased** by 8.6%.

Credit hours, headcount, and credit hours per student decreased when compared to Summer I of last year. All three measures are greater than Summer 2008 figures (i.e. the five-year period).

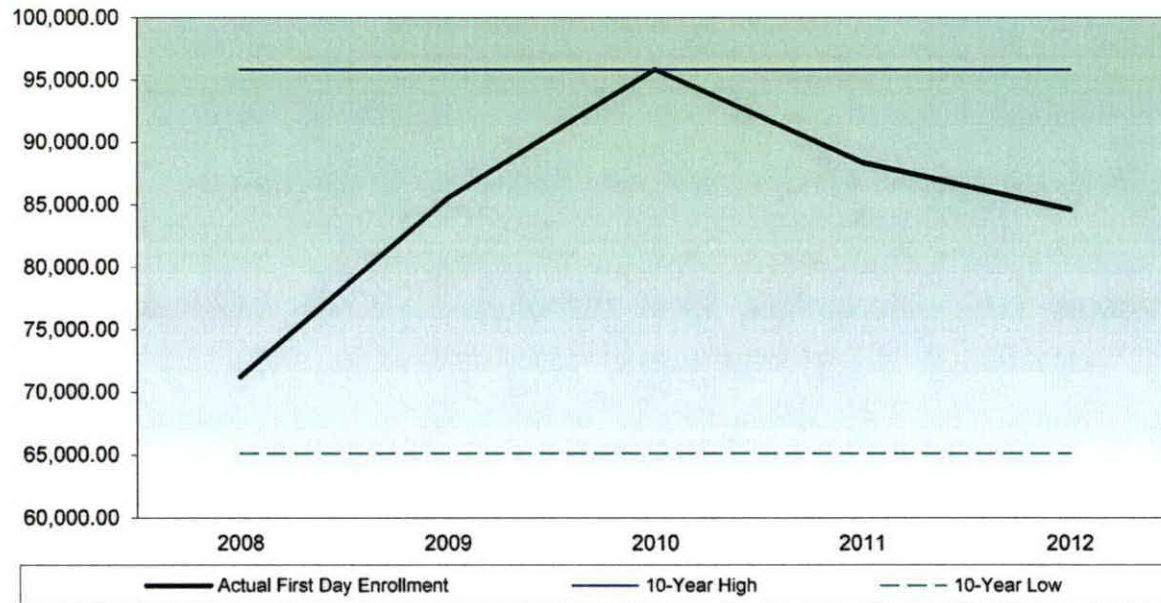

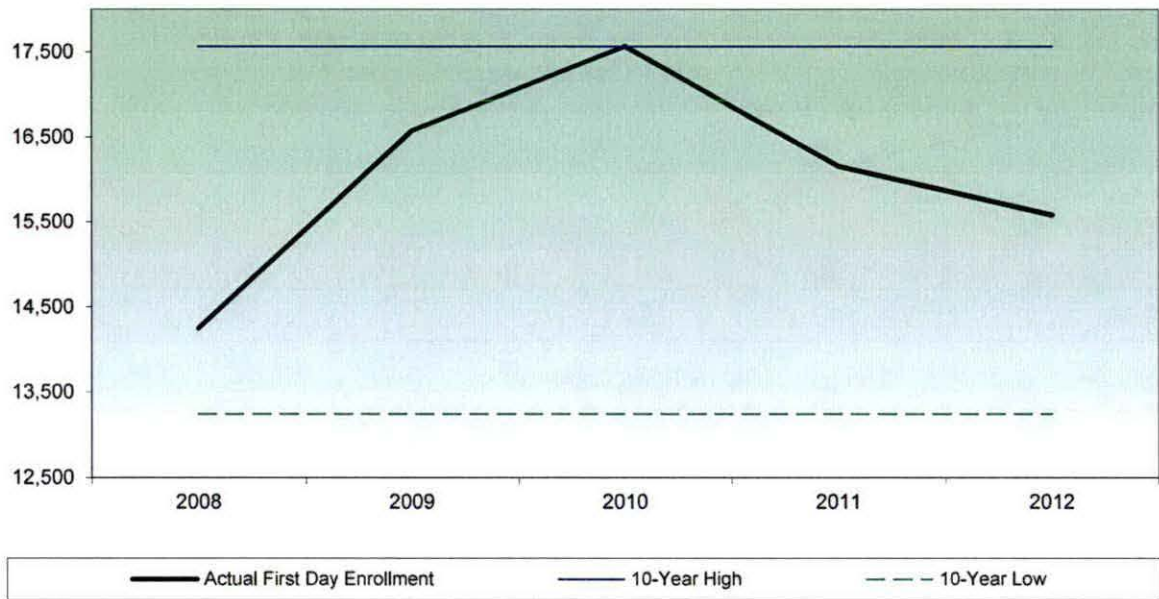

The following report contains data related to: 1) the number of student credit and non-credit hours; 2) total student headcount; and 3) the number of credit hours per student; as well as projections college-wide and by campus.

This report can be summarized by the following:

- College-Wide Student Credit and Non-Credit Hours combined (248,395.26) **increased** by 15.3% when compared to the same time period one year ago. Over a five-year period (2008-2012), combined Credit and Non-Credit Hours **increased** by 42.6%.
- College-wide Student Headcount (30,374) **increased** by 5.6% compared with the same time period last year, and **increased** by 24.4% over the five-year period.
- College-Wide End of Session Credit Hours per Student (8.18) **increased** by 9.2% over last year, and **increased** by 14.6% over the five-year period.

Overall, credit hours, headcount, and credit hours per student increased for both the 1-year and 5-year comparisons.

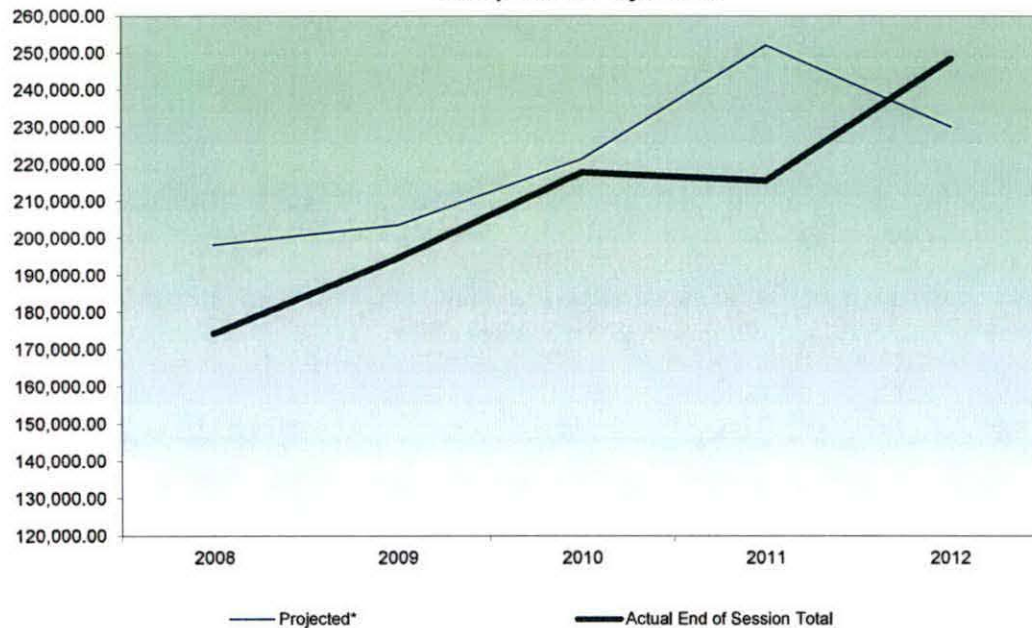

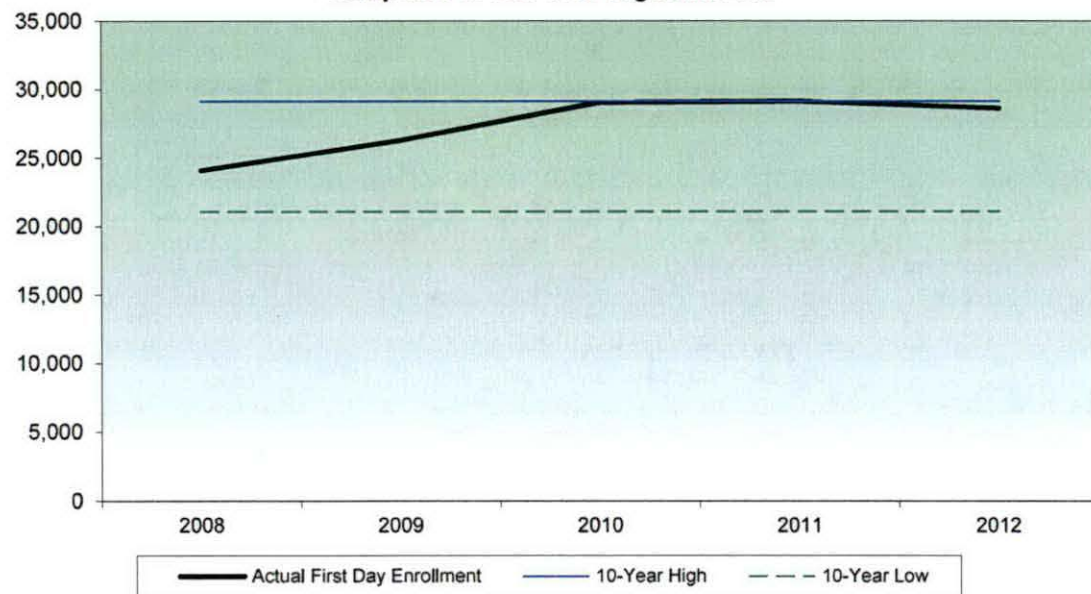
